ORDER APPROVING FINAL ACCOUNTING AND FINAL DISCHARGE;
AUTHORITY TO REIMBURSE THE INSURANCE COMMISSIONER'S REGULATORY
TRUST FUND; AUTHORITY TO TRANSFER REMAINING FUNDS TO THE
FLORIDA LIFE AND HEALTH INSURANCE GUARANTY ASSOCIATION; THE
FLORIDA INSURANCE GUARANTY ASSOCIATION; THE GEORGIA IINSURANCE
GUARANTY ASSOIATION; THE LOUISIANA INSURANCE GUARANTY ASSOCIATION
AND THE TENNESSEE INSURANCE GUARANTY ASSOCIATION
AND AUTHORIZING THE DESTRUCTION OF OBSOLETE RECORDS

THIS CAUSE came on for hearing on the Receiver's Motion for Approval of Final Accounting and Final Discharge, and Authority To Reimburse The Insurance Commissioners Regulatory Trust Fund and Authority To Transfer Remaining Funds to the Florida Life and Health Insurance Guaranty Association, the Florida Insurance Guaranty Association, the Georgia Insurance Guaranty Association, the Louisiana Insurance Guaranty Association, and the Tennessee Insurance Guaranty Association and Authorizing the Destruction of Obsolete Records, and Court being otherwise fully advised in the premises, it is

ORDERED and ADJUDGED that:

1. The Receiver's Final Accounting is hereby approved and the Receiver's administration of this receivership shall be deemed satisfied, approved, and confirmed in all respects, and the Receiver, its deputies and all other employees shall be discharged without further Order of this Court, from any and all duties,

obligations and liabilities in the administration of receivership at 12:01 A.M. on the 28th day of February, 1995.

- The Receiver is authorized to destroy the records belonging to the company. Prior to the actual destruction of any records, a Disposal Authorization Certificate shall be obtained by the Department of Insurance from the Division of Archives, History and Records Management of the Department of State. The provisions of this paragraph shall survive the entry of Final Discharge.
- 3. The Receiver is hereby authorized and directed to transfer the sum of \$13,339.51 to the Insurance Commissioner's Regulatory Trust Fund.
- The Receiver is authorized and directed to transfer \$36.06 to the Florida Life and Health Insurance Guaranty Association \$85,891.93 to the Florida Insurance Guaranty Association, \$6,435.00 to the Georgia Insurance Guaranty Association, \$1,051.93 to the Louisiana Insurance Guaranty Association, and \$779.79 to the Tennessee Insurance Guaranty Association.
