RECEIVER'S MOTION FOR APPROVAL OF FIRST AND SECOND INTERIM CLAIMS REPORTS AND RECOMMENDATION ON CLAIMS

The Florida Department of Financial Services as Receiver of National Group Insurance Company (hereinafter "the Receiver" or "NGIC"), by and through its undersigned counsel, hereby files this Motion for Approval of First and Second Interim Claims Reports and Recommendation on Claims, and as grounds therefore states as follows:

- 1. NGIC was a Florida corporation previously authorized to transact the business of a domestic property and casualty insurer in the State of Florida pursuant to chapter 624, Florida Statutes.
- 2. On October 10, 2011, this Court entered an Order Appointing the Florida Department of Financial Services as Receiver for Purposes of Liquidation, Injunction and Notice of Automatic Stay.
- 3. This Court has jurisdiction over the NGIC receivership and is authorized to enter all necessary and/or proper orders to carry out the purpose of the Florida Insurers Rehabilitation and Liquidation Act, section 631.021(1).
- 4. In accordance with section 631.182, the Receiver has compiled a First Interim Claims Report ("First Report") and a Second Interim Claims Report ("Second Report") (together "Reports") consisting of the Receiver's evaluations and recommendations as to claims filed in

the NGIC estate. The Reports consist of non-guaranty association claims in classes 1-10. There are no reported class 1 claims; only claims in class 2 were evaluated for claim amount due to the limited assets in the estate. Classes 3 through 10 were evaluated for class only.

- 5. The First Report shows 8,627 filed claims by non-guaranty association claimants totaling \$10,010,715.46, of which the total amount recommended by the Receiver to be paid is \$110,244.19. For the Court's convenience, a summary reflecting the totals from the First Report is attached as Exhibit A. The entire First Report totaling 1,234 pages is available to the Court upon request.
- 6. The Second Report shows 2 filed claims by non-guaranty association claimants totaling \$2,000,001.00, of which the total amount recommended by the Receiver to be paid is \$520,825.00. For the Court's convenience, a summary reflecting the totals from the Second Report is attached as Exhibit B. The entire Second Report totaling 2 pages is available to the Court upon request.
- 7. In order to assure the validity of claim assignments, to assure that the processing of assignments does not create an undue burden on estate resources, and to assure that assignment decisions are made using the best information available, the Receiver does not recognize or accept any assignment of claim by the claimant of record unless the following criteria are met:
 - A. A distribution petition has not been filed with this Court;
- B. The Receiver has been provided with a properly executed and notarized assignment of claim agreement entered into between the parties; and
- C. The Receiver has been provided with a properly executed and notarized Receiver's Assignment of Claim Change Form and required supporting documentation.

- 8. The Receiver's Assignment of Claim Change Form shall contain an acknowledgement by the claimant, or someone authorized to act on behalf of the claimant, that:
- A. The claimant is aware that financial information regarding claims distributions and payments published on the Receiver's website or otherwise available can assist the claimant in making an independent and informed decision regarding the sale of the claim;
- B. The claimant understands that the purchase price being offered in exchange for the assignment may differ from the amount ultimately distributed in the receivership proceeding with respect to the claim;
- C. It is the claimant's intent to sell their claim and have the Receiver's records be permanently changed to reflect the new owner; and
- D. The claimant understands that they will no longer have any title, interest, or rights to the claim including future mailings and distributions if they occur.
- 9. Pursuant to section 631.182, claimants are entitled to notice of the Receiver's recommendation on their claims and the deadline for filing an objection. The deadline to be established for filing objections will not be less than forty five (45) days from the date of this Court's Order granting approval of the Reports. A sample copy of the "Notice of Determination" containing this information and provided to claimants is attached hereto as Exhibit C.
- 10. The Receiver has a procedure for dealing with late-filed objections. For any objection filed after the deadline, the Receiver will send a letter to the claimant advising the claimant that his/her/its objection was not filed in compliance with the Florida Statutes and this Court's Order and therefore will not be handled as a filed objection. A copy of this letter will be filed with the Court.

11. The Receiver requests that the recommendations set forth in the Reports be approved unless an objection is filed thereto within the deadline approved by the Court.

WHEREFORE the Receiver respectfully requests this Court enter an Order:

A. Approving the Receiver's First Interim Claims Report and Recommendations on Claims for which no objections are filed.

B. Approving the Receiver's Second Interim Claims Report and Recommendations on Claims for which no objections are filed.

C. Authorizing and directing the Receiver to provide notice to each claimant, as herewith reported to the Court, of the Receiver's recommendation regarding his/her/its claim, by United States Mail to the last known address of such person or entity, as shown in the Receiver's files.

D. Authorizing the Receiver to establish an objection filing deadline that is not less than forty-five (45) days from the date of this Court's Order granting approval of the Receiver's Report.

E. Approving the Receiver's sample Notice of Determination, and directing all persons or entities who have filed claims, or had them deemed filed, to file in writing any objection to the Receiver's Report they might have with the Clerk of this Court by the objection filing deadline, at:

F. Requiring any person filing an objection to clearly state the name and claim identification number of the person filing the objection and to provide documentation supporting the objection and claim, and that the Court will not consider any information or documentation submitted after the objection is filed

G. Approving the Receiver's procedure for addressing late filed objections.

H. Approving the Receiver's procedure for recognizing and accepting assignment of claims.
