- <u>Next Gen MFMP</u> The Next Generation MFMP Contract DMS-20/21-150 was executed in June 2021, effective July 1, 2021 to June 1, 2026.
- <u>Customer Support Operation Innovations</u> There are MFMP Customer Support Operational Innovations taking place for this project including:
  - o Release 1 ServiceNow CRM Implementation Complete as of November 1
  - o LogMeIn Live Guide Co-Browsing Implementation Complete as of January 3
  - MFMP FAQ Bot Implementation In Progress Expected completion March 28
  - MFMP Live Agent Chat Coming Soon Expected July 2022
- Release 2 Currently in progress is the VIP Cloud Transformation. Stakeholder Design Workshops and Design Review & Approval stages have been completed. In the coming weeks, communication will be sent out regarding development and testing of Release 2.
- <u>Release 3</u> Also in progress is the AOD Cloud Transformation. Stakeholder Design and Prototype workshops have been completed. The Customer Roundtable Meeting (CRT) for this release is scheduled for Thursday, February 10. Next Gen AOD Training will be held May-June 2022.

- <u>Florida PALM Access Quarterly Reviews</u> A quarterly review of all Florida PALM users has been implemented. Moving forward, agencies are being asked to implement these quarterly reviews into their procedures and continue to process these reviews in a timely manner.
- Outstanding Warrant Report Issue When December's report was ran, there was an
  error in processing, making it seem as if agencies did not have any outstanding reports.
  This error was recognized quickly and OIT has provided Excel reports with the
  information agencies need regarding outstanding warrants.
- <u>Data Management Statistics</u> Starting this Spring, conversion items will begin being discussed with Florida PALM. Additional discussion will take place mid-late Spring regarding future changes.
