FY 22/23, AA Memo #7 – STATE AGENCY PAYROLL COMPLIANCE CHECKLIST – Issued: September 29, 2022 – The Department of Financial Services (Department) is responsible for processing payrolls for all state agencies. We have updated the State Agency Payroll Compliance Checklist to provide the Department with reasonable assurances that state agencies are presenting accurate and reliable information to the Bureau of State Payrolls (BOSP) for payroll processing and to ensure compliance with the applicable guidelines governing this process.

FY 22/23, AA Memo #8 – FLORIDA ACCOUNTING INFORMATION RESOURCE (FLAIR) WARRANT CANCELLATION (WC) UPDATE – Issued: November 10, 2022 – In order to improve reporting, a new status code will be used to distinguish prior year warrant cancellations from current year warrant cancellations. When a warrant issued in the prior fiscal year is cancelled, it will now be assigned status code 6. Warrants issued and cancelled in the same fiscal year will still be assigned status code 3.

The EIC provides current and former state employees the ability to make inquiries into their payroll information. This includes:

- Current W-4 information
- Five years of earnings statements, W-2 forms and reimbursements (i.e. travel and flexible benefits)
- Verification of eligibility for tuition waiver program
- Electronic W-2 registration for faster and more secure access to tax information.
