Training Program Update

As our State moves closer to implementing a new statewide accounting system, our agency partners are investing time to prepare for the change, while still using the Departmental FLAIR component for agency accounting needs for the next several years. To support agencies with FLAIR training, we are making updates to our FLAIR training program. The FLAIR two-day classes will no longer be offered beginning April 1, 2021. We will be offering shorter topic-based trainings. Examples include:

- Governmental Accounting
- Understanding FLAIR data elements
- How to pay an invoice
- Voucher processing and payment history information
- Payment life cycle
- Certified Forward preparation and processing
- Processing Deposits
- Corrections and reconciliation

We will be offering the new topics beginning in July. The training calendar will continue to be maintained on the training website.

FY 20/21, AA Memo #19 – JUDGMENT INTEREST RATE FOR THE QUARTER BEGINNING April 1, 2021 – Issued: March 3, 2021 – Chapter 2011-169, Laws of Florida, amended section (s.) 55.03(1), Florida Statutes (F.S.), to require the Chief Financial Officer (CFO) to set the rate of interest that shall be payable on judgments and decrees on a quarterly basis rather than an annual basis. Sections 215.422(3)(b), 337.141(3) and 687.01, F.S., require the use of the interest rate established in s. 55.03(1), F.S.

FY 20/21, Proposed AA Memo – LOCAL FUNDS – PREPARATION FOR FLORIDA PALM CONVERSION – Issued: TBA – As the State of Florida transitions its accounting system from FLAIR into Florida PALM, state agencies are requested to account for their revolving and clearing funds as a State Fund 8. For state agencies that have not already established Local Funds for their bank accounts, we request they establish a unique fund account within FLAIR for each local fund utilized by agencies to conduct state business. In addition to State Fund 8, additional account values in the chart of account fields as used as a parent fund (few exceptions apply).
