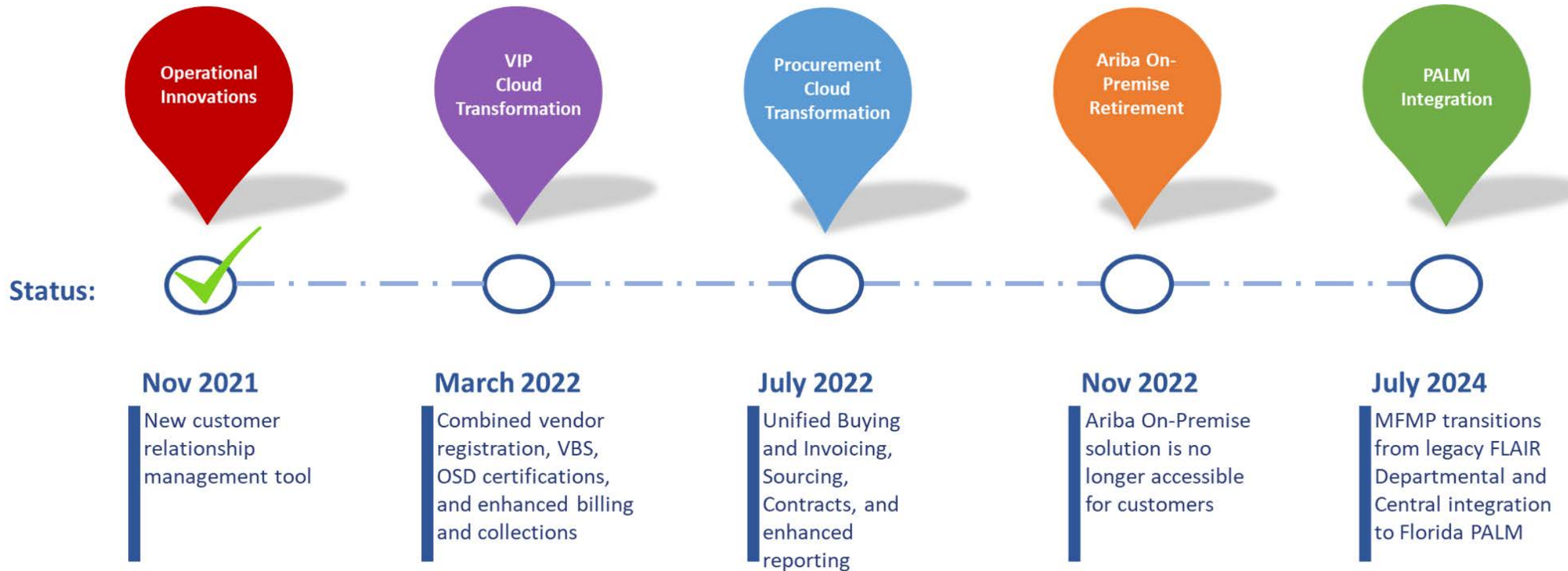

Release 3: Procurement Cloud Transformation

There will be a dual processing period after Next Gen MFMP goes live on July 5, 2022, until the current MFMP applications are retired in November 2022



Using the current MFMP applications and Next Gen MFMP during the dual processing period

Current MFMP applications

Used to create receipts, pay invoices, and release encumbrances for FY2021-22 Purchase Orders or Certified Forwards

Next Gen MFMP applications

Used to create all new orders, process receipts, pay invoices, and manage those orders

Password management and dual access.

- ! Users who access both systems may need to use different passwords to log into each system as security standards have increased with Next Gen MFMP.
