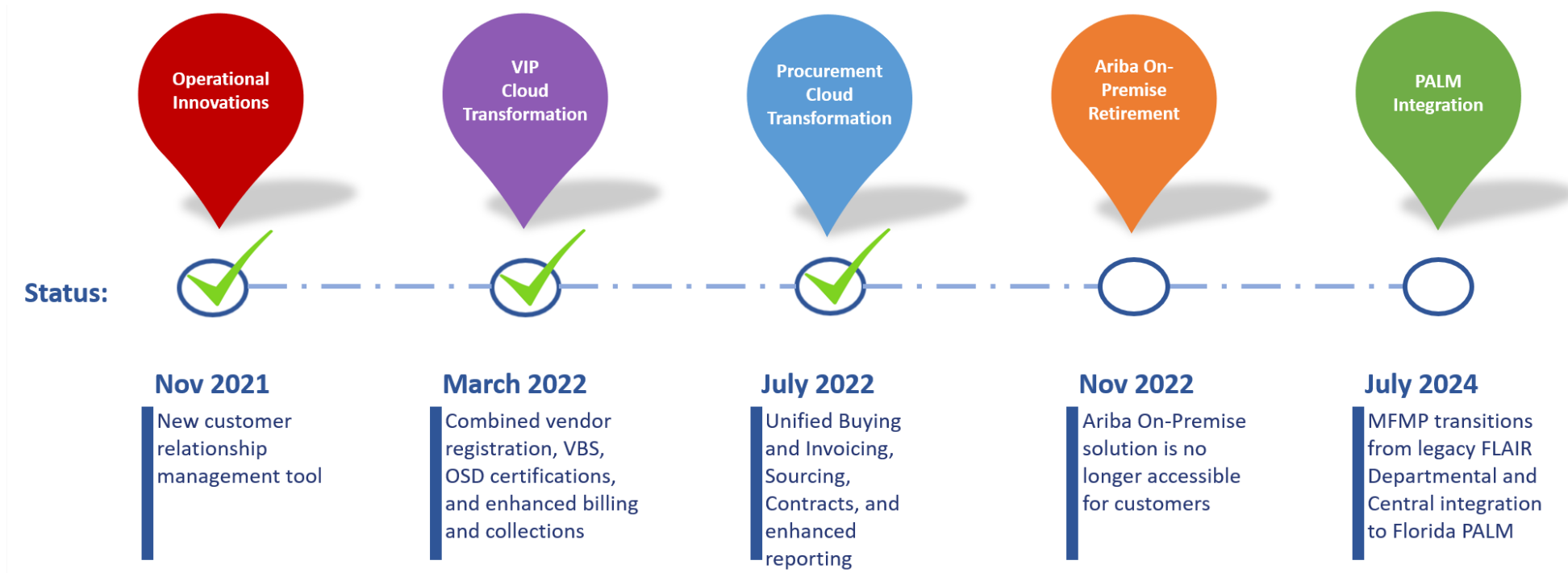




# MyFloridaMarketPlace Go-Live

# MFMP Stabilization

## HIGH PRIORITY ISSUES SUMMARY

Issue	Description	Functional Area	Status
Some agencies are unable to submit invoice reconciliations due to a "Password Not On File" error	Multiple agency customers reported issues with submitting invoice reconciliations due to the "Password Not On File" error. The agencies confirmed their FLAIR login credentials were properly recorded and valid in MFMP.	Buying and Invoicing	Closed
Workflow Issues	<p>Some agency workflows did not generate the proper PUI-based user group.</p> <p>Some agency requisition workflows did not generate the supervisor approval chain.</p> <p>Some agency requisition workflows generated a supervisor whose threshold is below the requisition amount.</p>	Buying and Invoicing	Closed
Cross-agency receipt visibility	Multiple agencies reported that they could view other agencies' receipts in the "To Do" queues.	Buying and Invoicing	Closed
Agency Accounting Issues	The COA correlation validation requires some agency customers to only choose correlated values for the Project and Contract ID fields, preventing some agencies from submitting requisitions using non-correlated Project and Contract ID values.	Buying and Invoicing	Closed
Delegation of Approval Authority	Delegation of Authority requests submitted via the eForm are not set consistently.	Buying and Invoicing	Investigation
Office Depot (ODP) auto-rejection of POs	Office Depot (ODP) is auto-rejecting purchase orders.	Buying and Invoicing	Investigation
