I should not have to remind people of this simple fact, but it often seems as though most of our country has unfortunately forgotten.

The impact of this storm is overwhelming: \$6.2 billion in insured losses across 15 affected counties (compared to \$11 billion in insured losses for Hurricane Irma in 49 affected counties); according to reports, Bay District Schools has lost a reported 30 percent of its student population; over eighty percent of the tree cover at the Florida Caverns State Park in Jackson County was obliterated; hospitals are still not operating at full capacity; and 20 million cubic tons of debris and 72 million tons of fallen trees across affected counties, increasing fire and flooding risks.

It is unthinkable that partisan politics and self-interest has obstructed federal disaster recovery funding, especially considering the magnitude of the destruction.
