**MOTION TO AMEND ORDER APPROVING THE RECEIVER'S
FIRST INTERIM CLAIMS REPORT AND RECOMMENDATION ON CLAIMS**

The Florida Department of Financial Services, as Receiver of the Armor Insurance Company (hereinafter the "Receiver"), files this motion seeking to amend the Order Approving the Receiver's First Interim Claims Report and Recommendation on Claims and in support of its motion, the Receiver states:

1. This Court recently approved the Receiver's First Interim Claims Report and Recommendation on Claims on June 5, 2009. See attached Exhibit A.
2. As a condition of the Order, the Court approved a deadline date for filing objections to the claims report by July 15, 2009. The Receiver's staff has reevaluated the time periods needed to provide notice to all claimants and believes that additional time is needed. All other conditions of the Court's Order would not be changed, but for moving the deadline for objections to be filed on or before 11:59 p.m. on August 14, 2009.

WHEREFORE, the Receiver respectfully requests this Court enter an Order:

3. Any person filing an objection is required to submit documentation to support their claim.


4. This Court will not consider any information or documentation, submitted subsequent to the filing of the objection, in opposition to the Receiver's evaluation of the claim.
