**RECEIVER'S REPORT AND PETITION FOR ORDER**  
**APPROVING AND DIRECTING THE RETURN OF ASSESSMENT FUNDS TO**  
**CADUCEUS MEMBERS**

THE FLORIDA DEPARTMENT OF FINANCIAL SERVICES, as Receiver of Caduceus Self Insurance Fund, Inc. ("Receiver"), hereby makes and files its report and petition for order approving and directing the return of assessment funds to Caduceus members. In support of its Motion, the Receiver says:

1. Caduceus Self Insurance Fund, Inc., ("Caduceus"), was a Florida corporation previously authorized to transact the business of a physician's medical malpractice self insurance fund in the State of Florida. On January 3, 2000, the Second Judicial Circuit Court in and for Leon County, Florida ("Court"), entered its Order Appointing the Florida Department of Insurance as Receiver for Purposes of Liquidation, Injunction and Notice of Automatic Stay (hereinafter "Consent Order"). On January 7, 2003, the Florida Department of Insurance became a part of the Florida Department of Financial Services.

2. This Court has jurisdiction over the Caduceus Receivership and is "authorized to make all necessary or proper orders to carry out the purposes of" the Florida Insurers Rehabilitation and Liquidation Act. Section 631.021(1), Florida Statutes.

3. Caduceus was organized pursuant to § 627.357, Fla. Stat., and Chapter 4-187, F.A.C. According to the terms of the Caduceus Professional Medical Liability Insurance

Assessable Claims Made Policy (“Policy”) and the Caduceus Self Insurance Fund, Inc. Mutual Covenants (“Mutual Covenants”), the members of Caduceus pooled their medical malpractice liabilities under the direction of a board of trustees. Among other things, the members of Caduceus agreed to pay into a fund premiums and assessments necessarily determined by the trustees, out of which actual losses and expenses were to be paid. Moreover, the members of Caduceus agreed to make prompt payment of said premiums and assessments.

4. Pursuant to the terms of the Policy and Mutual Covenants of Caduceus, and in accordance with § 627.357(7)(c), Fla. Stat., the trustees, and the Receiver in the event of liquidation of the fund, could assess the members of Caduceus to cover liabilities of the fund.

5. Further, the Consent Order authorized and directed the Receiver to calculate, in the manner set forth in § 624.474, Fla. Stat., any necessary assessments and to use the collection procedure set forth in §§ 631.311, 631.321, and 631.331, Fla. Stat., or such other procedure as may be subsequently ordered by this Court.

6. After a thorough investigation, the Receiver determined that the assets of Caduceus were insufficient to satisfy its liabilities so the Receiver, pursuant to § 631.311, Fla. Stat. (2002), made and filed its report and petition to this Court setting forth the reasonable value of the assets of Caduceus, the liabilities of Caduceus to the extent thus far ascertained by the Receiver, the aggregate amount of the assessment which the Receiver deemed reasonably necessary to pay all claims, the costs and expenses of the collection of the assessments, and the costs and expenses of the delinquency proceeding in full. The assessment levied by the Receiver took into account a 1999 assessment levied against Caduceus members by Caduceus management.

7. On January 3, 2003, the Court entered its Order Approving and Directing the

Assessment of Fund Members (hereinafter "Assessment Order"). The Assessment Order authorized and directed the Receiver to assess the fund members of Caduceus in the aggregate amount of \$15,581,798.00 in accordance with the classification and formula created by the Receiver and approved by the Court.

8. To date, the total assessment related payments collected for all insureds is \$14,998,140.18.

9. The assessment was only one of the Receiver's asset recovery efforts. The Receiver also successfully prosecuted a breach of contract action against The Doctors Company, a large California insurance company. The action against The Doctors Company netted the Caduceus estate an additional approximately \$16.4 million plus another approximately \$1.4 million in fees and costs. The Receiver is also currently litigating a case against the former accountants for Caduceus.

10. The Receiver made the assessment in 2003 to comply with the 3 year time limit mandated by Section 631.311, Florida Statutes. The assessment calculations were actuarially determined and were based upon the best information available to the Receiver at the time of the assessment. The Doctors Company recovery occurred after the assessment was made and was not contemplated in the assessment due to the inherent unpredictability of litigation.

11. All but two of the claims against the Caduceus estate have been adjudicated and approved by this court (A paper copy of the summary totals from the Final Claims Report is attached as Exhibit A). The two remaining claimants (Alfred C. Bender and Susan Bender, ID# 78-2; and Zelda Williams, ID# 97-2) are pursuing appeals in the First District Court of Appeal. Because the appeals are still pending, the Receiver did not include the Bender or Williams claims in the Final Claims Report. As a precaution, the Receiver has reserved an amount equal to the

amount of the judgment upon which each claim is based (\$2 million per claim) to be held by the Receiver until such time as the claims are finally resolved.

12. The Receiver has completed a distribution to classes 1-3 (other than the Bender or Williams claim).

13. Due to the Receiver's successful asset recovery efforts, the assets available in the Caduceus estate clearly exceed the estate's liabilities (see the Receiver's Distribution Accounting, attached as Exhibit B). Obviously, if the Receiver had been able to incorporate the information regarding The Doctors Company recovery into the assessment calculations, the results of those calculations would have been very different. Based upon this situation, the Receiver asked the actuaries who prepared the original assessment report to reexamine the assessment calculations with the goal of determining a fair, equitable, actuarially sound formula and process for returning some portion of the assessment funds. The actuaries reported the results of their examination in their "Determination of Process and Calculations to Return Assessments by Insured" attached to this motion as Exhibit C.

14. After reserving for the Bender and Williams claims, the remaining claims in classes 4-10 and the estimated administrative costs over the remaining life of the estate, the Receiver determined that up to \$11,000,000 was available to return to the Caduceus fund members who had paid either a portion or the entirety of the levied assessments (see Exhibit B). An \$11,000,000 return would represent 73.3424% of the \$14,998,140.18 in assessment principal and interest collected from Caduceus fund members. The Receiver anticipates further reinsurance and tax recoveries that may necessitate an additional return to Caduceus fund members at some point in the future.

15. Each payment amount to individual fund members will be determined using the formula developed by the actuaries that is included in Exhibit C.

16. Despite the Receiver's best efforts, some approved returned assessment amounts intended for former Caduceus fund members may have inadequate current address information. The Receiver asks for authority to remit the funds due these claimants to the Unclaimed Property Bureau of the Department of Financial Services.

**WHEREFORE**, the Receiver respectfully requests this Court grant its Motion and enter an Order approving the Receiver's plan to return a portion of the assessment funds to Caduceus fund members.

## **I. INTRODUCTION**

The Florida Department of Financial Services, Division of Rehabilitation and Liquidation (DFS) has engaged Preferred Insurance Capital Consultants, LLC, (PICC) to assist in the matter of the Caduceus Self-Insured Fund, In Liquidation (Caduceus). Caduceus provided coverage for the medical malpractice exposure of a group of owner-healthcare providers. Formerly headquartered in Fort Lauderdale, Florida, Caduceus is currently in run-off mode. Caduceus was placed in liquidation by Court order on January 3, 2000. The DFS was appointed as Receiver for purposes of liquidation.

In 2003, the DFS assessed each Caduceus member (insured) in order to settle Caduceus' outstanding liabilities. PICC provided actuarial and other consulting services in connection with the assessment process. Subsequent to the assessment being levied, DFS has succeeded in obtaining for Caduceus a substantial recovery of funds. As a result, DFS has determined that a substantial amount of assessment dollars will not be required in order to settle the affairs of the Caduceus estate. DFS has asked that PICC determine a fair, equitable, and actuarially-sound formula and process for allocating to individual insureds an aggregate refund as determined by DFS (hereafter referred to as the "allocation process").



## **II. DETERMINATION OF BASIS FOR RETURNING ASSESSMENT DOLLARS TO INSUREDS**

### **A. History of Assessments**

There have been two instances of assessments being levied against insureds. The first assessment was in July 1999. The second assessment was in January 2003.

### **B. Determination of Assessment Amounts**

The 1999 assessment by insured was determined by Caduceus management, and did not include any provisions to recognize failure of some insureds to pay assessments, time value of money, etc.

The 2003 assessment by insured was determined by DFS and reflected:

1. The underwriting experience of individual policy years,
2. Unpaid 1999 assessments and credit for paid 1999 assessments,
3. The cost of expected future uncollectible assessments,
4. The cost of a discount for prompt payment, and
5. Interest on assessment balances due.

### **C. Refund by Insured of Aggregate Amount Determined by DFS**

DFS has successfully pursued through negotiations and litigation amounts owed to Caduceus by outside parties. As a result of DFS' successful recovery of monies to Caduceus, DFS is in the process of determining an amount of assessment that will be returned to insureds. PICC's responsibility is to provide DFS with an appropriate allocation process.

### **D. Data Available for Assignment**

DFS provided PICC with an electronic file (see Exhibit A, attached) that lists by policy:

1. The policy number,
2. The amount of 1999 assessment paid,
3. The amount of 2003 assessment paid, and
4. The amount of interest paid.

DFS was able to provide, by insured, the amount of credit for prompt payment, the amounts written-off, and amounts of judgments. However, PICC has determined that this additional information does not provide any value in determining the allocation process. PICC concludes that the

allocation process should be based on actual 1999 and 2003 assessment payments made, net of credit for prompt payment, and inclusive of interest charges paid.

DFS has advised PICC that PICC should assume that there will be no unexpected liabilities arising and that responsibility for determination of the total aggregate amount of assessment refund rests with DFS, not PICC.

#### **E. Recommended Allocation Process**

Exhibit A (attached) is a printed copy of an electronic Excel format spreadsheet that has been provided to DFS as a part of this report.

Columns (a) through (f) display data provided to PICC by DFS. Column (a) identifies insureds by policy number. Column (b) displays the surname or corporation name for each insured. Column (c) displays the first name for each insured. Column (d) displays the amount of 1999 assessment actually paid by insured. Column (e) displays the amount of 2003 assessment actually paid by insured. Data in columns (d) and (e) includes interest payments made by insured, and is net of credits for prompt payment. Column (f) displays the date of last payment by insured.

Column (g) displays the sum, by insured, of the data in columns (d) and (e). That is, column (g) displays total assessment related payments by insured. The total assessment related payments for all insureds is the total for column (g), or \$14,998,140.18

Column (h) displays each insured's total payment as a percentage of the total amount of assessments and interest paid by all insureds, rounded to fourteen decimal places.

The first numeric value displayed in column (i), \$5,000,000, is a sample value to illustrate how much refund would be provided to each insured if DFS determined that the total refund should be \$5,000,000. In the electronic version of Exhibit A provided to DFS, if DFS substitutes an alternative amount in lieu of \$5,000,000, the spreadsheet will automatically recalculate the values by insured in column (i) using the percentages by insured displayed in column (h).

The allocation process described above is only valid if the aggregate amount of refund as determined by DFS is less than the total amount of assessment collected (including interest collected) as a result of the 1999 and 2003 assessments (e.g., \$14,998,140.18). If the aggregate amount of refund is larger than the total amount of assessment collected, the

process for determining refunds by insured should be substantially revised.

### III. CAVEATS AND LIMITATIONS

- A. **Entire Document** – The conclusions within this study are developed in the accompanying text and exhibits, which together comprise the report.
- B. **Distribution** – The report was prepared for the sole use of the Florida Department of Financial Services, Division of Rehabilitation and Liquidation (DFS). Distribution to others without our prior written consent is unauthorized. With our consent, the report may be distributed only in its entirety.
- C. **Data Reliance** – The data for this study was provided by the DFS. In the study, we relied on the accuracy and completeness of this data without independent audit. If the data is inaccurate or incomplete, our findings and conclusions may need to be revised.
- D. **Valuation Date** – The valuation date for the study is August 28, 2007 (the date for the most recent payment as displayed in Exhibit A, column (d)).
- E. **Management Reliance** – Information concerning the Caduceus program structure and risk exposure was provided by DFS. In the study, we relied on the accuracy and completeness of this information without independent verification. If the information is inaccurate or incomplete, our findings and conclusions may need to be revised.
- F. **Underlying Assumptions** – In addition to the assumptions stated in the report, numerous other assumptions underlie the calculations and results presented herein.
- G. **Best Estimate** – These caveats and limitations notwithstanding, the conclusions represent our best estimate of the requirements of the program as of the date of this report.
