**DEPARTMENT'S MOTION FOR APPROVAL OF AMENDED FINAL CLAIMS
REPORT AND AMENDED CLAIMS DISTRIBUTION REPORT**

THE FLORIDA DEPARTMENT OF FINANCIAL SERVICES, as Receiver of Atlantic Preferred Insurance Company ("Department"), hereby moves this Court for an Order Approving the Amended Final Claims Report and Amended Claims Distribution Report, and as grounds would state as follows:

1. Atlantic Preferred Insurance Company, ("APIC"), was a Florida corporation previously authorized to transact the business of insurance in the State of Florida. On June 1, 2006, the Second Judicial Circuit Court in and for Leon County, Florida ("Court"), entered its Order Appointing the Florida Department of Financial Services as Receiver for Purposes of Liquidation, Injunction and Notice of Automatic Stay ("Order").

2. This Court has jurisdiction over the APIC Receivership and is authorized to enter all necessary and/or proper orders to carry out the purpose of the Florida Insurers Rehabilitation and Liquidation Act (Section 631.021(1), Florida Statutes).

3. On December 12, 2016, the Department filed its Motion for Approval of the Final Claims Report, Claims Distribution Report, and Distribution Accounting, and for Order Authorizing Distribution ("the Motion"). The Order approving that Motion was entered on December 13, 2016 and is attached as Exhibit A.

4. In the original Motion, the Department attached the summary page from the

Final Claims Report as Composite Exhibit B. In Part A of that Exhibit, the document reflected that the amount recommended to be paid for Class 2 non-guaranty claims totaled \$1,726,441.42.

5. Pursuant to the Order, the Department distributed the approximately \$4,892,021.45 to Class 1 and pro rata to Class 2 claimants. As the Department began reviewing returned checks and preparing this receivership estate for eventual discharge, it was discovered that one of the returned checks had been printed in an incorrect amount. A letter was sent to that claimant, who was advised that funds in the correct amount can be claimed from the Division of Unclaimed Property: since the Department is so close to the anticipated discharge date, the time for issuing new checks has passed.

6. In order to properly reconcile the final accounting of the APIC estate, the Department prepared an Amended Final Claims Report, and an Amended Claims Distribution Report. Both documents reflect the final totals that now include the corrected amount with the above claim payment. The summary pages of each document are attached hereto respectively as Exhibit B and Exhibit C. The only changes are found in the Amount Recommended for Class 2 Claims on each Report.

7. As a status to the Court, the Department intends to conclude this receivership and seek approval of discharge in June, 2017, with discharge of the Department as Receiver to be effective as of June 30, 2017.

WHEREFORE, the Receiver respectfully requests this Court grant its Motion and enter an Order Approving the Amended Final Claims Report and the Amended Claims Distribution Report on the foregoing grounds.
