THIS CAUSE having come before the Court on the *Receiver's Status Report and Motion for Approval of Rehabilitation Plan*, the Court having reviewed the pleadings of record, and otherwise being fully informed it is

ORDERED AND ADJUDGED:

1. The *Receiver's Status Report and Motion for Approval of Rehabilitation Plan* (hereinafter "Motion") is hereby GRANTED.

2. A claim filing deadline bar date is hereby established for Florida Select Insurance Company ("Florida Select"). The claim filing deadline bar date shall be one hundred eighty (180) days from the date of this Order. The deadline shall apply to the claim filing timeframes set forth under Chapter 631, Florida Statutes. All claims against Florida Select are to be submitted to the Receiver on or before the claim filing deadline bar date. In the event that a claim is submitted after the claim filing deadline bar date, it shall be denied unless otherwise ordered by this Court.

3. The Receiver is authorized to issue Notice to claimants including, but not limited to, publication as set forth in the *Receiver's Status Report and Motion for Approval of Rehabilitation Plan*.


4. The Receiver is authorized and directed to continue ongoing operational activities in the receivership as it deems necessary and appropriate.

5. The Receiver is authorized and directed to continue the asset recovery efforts set forth in the *Receiver's Status Report and Motion for Approval of Rehabilitation Plan* as it deems necessary and appropriate.

6. The authority granted to the Receiver under Chapter 631, Florida Statutes, and the Consent Order previously entered by this Court on June 30, 2006 is still in effect.

7. The automatic stay provisions set forth in Section 631.041, Florida Statutes, and the Consent Order are still in effect.
