**ORDER AUTHORIZING SIXTH EARLY ACCESS DISBURSEMENTS
TO ELIGIBLE GUARANTY ASSOCIATIONS**

THIS MATTER was considered upon the Department’s *Sixth Application for an Order Authorizing Early Access Disbursements to Eligible Guaranty Associations* in the Southern Fidelity Insurance Company (“SFIC”) receivership. The Court, having reviewed the motion and being otherwise fully advised in the premises, finds the following:

1. The Guaranty Associations listed in “Exhibit C,” as attached to the Department’s Sixth Application, are the guaranty associations contemplated by section 631.397, Florida Statutes, which provides in substance that the Department may disburse assets out of the insolvent insurer’s marshaled assets to each guaranty association entitled thereto, as such assets become available.

2. The written Early Access Agreement, attached to the Department’s Sixth Application as “Exhibit A,” between the Department and the eligible Guaranty Associations, satisfies the requirements of section 631.397, Florida Statutes.


3. The court has previously authorized the disbursement of **Two Hundred Twenty-Two Million, Eight Hundred Seventy-Two Thousand, Four Hundred Ninety-Four Dollars and 00/100 (\$222,872,494)** to eligible Guaranty Associations in the SFIC receivership.

4. The Department has adequate liquid assets available, as evidenced by the reported SFIC receivership Financial Statement of Affairs as of December 31, 2025, attached to the Department’s Sixth Application as “Exhibit B,” to provide the eligible Guaranty Associations

with the requested aggregate Early Access disbursement of **Nineteen Million, Seven Hundred Fifty-Four Thousand, Nine Hundred Forty-One Dollars and 00/100 (\$19,754,941)** for incurred claims and administrative expenses.

THEREFORE, it is **ORDERED** and **ADJUDGED** that the Department is authorized and directed to release **Nineteen Million, Seven Hundred Fifty-Four Thousand, Nine Hundred Forty-One Dollars and 00/100 (\$19,754,941)**¹ as early access funds to the Guaranty Associations as listed in “Exhibit C” of the Department’s Sixth Application.
