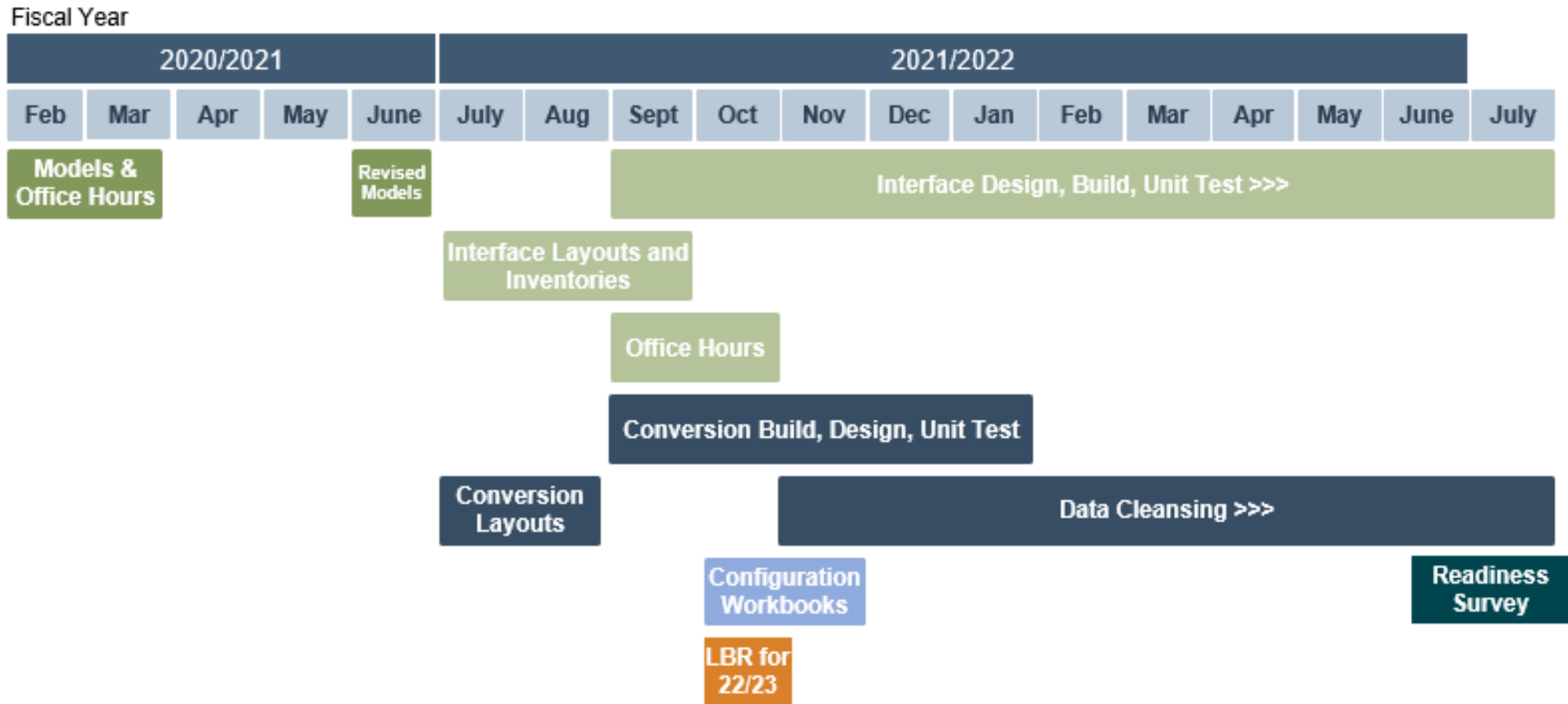

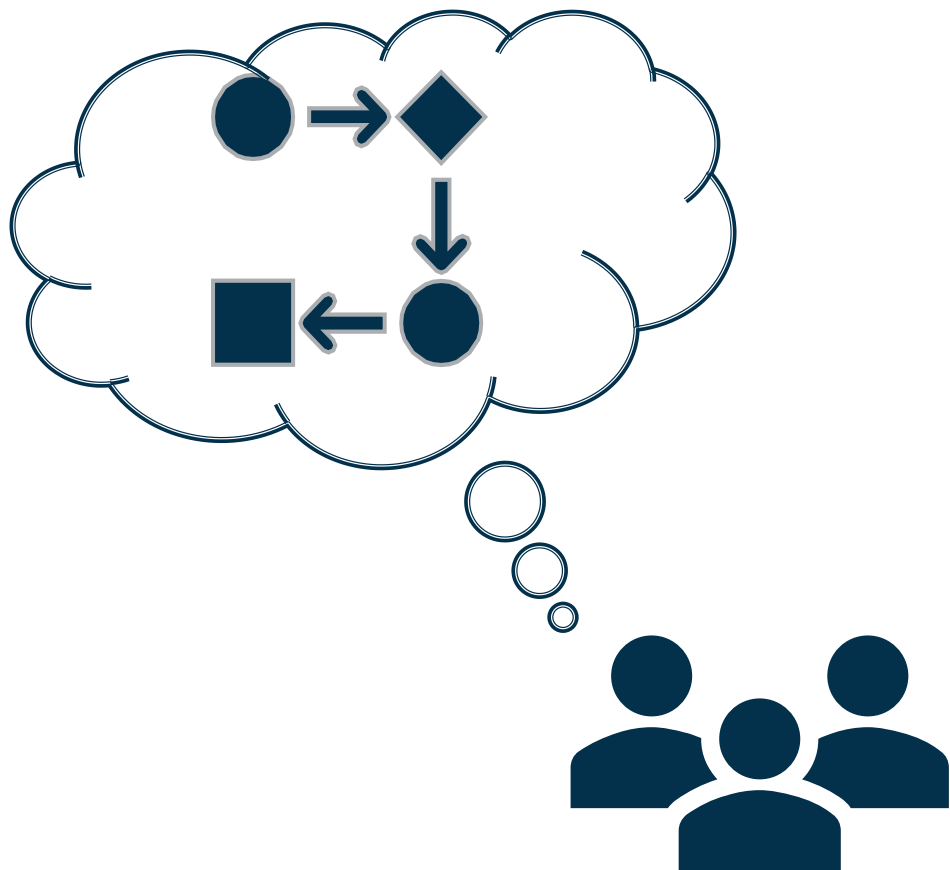

Recording Contracts	Supplier contract functionality was removed from process models due to FACTS contract functionality being included in Phase 2.	No impact - agencies will continue to enter contract information in FACTS	30.2.1 Create and Maintain Encumbrances
Payment Offsets	Offsetting functionality was removed from process models due to decision to not introduce new functionality of offsetting payments to cover outstanding receivables until Phase 2.	No impact – this process is not done in FLAIR today	30.3.1 Process Vouchers 30.4.1 Process Pay Cycle 60.2.4 Offsets
CMIA Reporting	Cash Management Improvement Act (CMIA) annual report preparation was updated on models because grant billing information will not be maintained in Florida PALM until Phase 2	No impact – this process is not done in FLAIR	80.2.8 Monitor CMIA

# Updates to Standardized BPM Office Hours

## Approach Change – InterUnit Functionality

- ▶ **Key Process Activity 1**
  - Payment for Goods and Services and Cash Transfers
- ▶ **Agency Impact**
  - Agencies may create bills using Customer Billing process
  - Agencies process payments for intra and inter unit transfers using the Accounts Payable Voucher which will generate and interunit payment
  - The intra and inter unit payments are integrated to the deposits processes to automatically create a deposit using the invoice number to connect the transactions
  - The receiving agency enters the accounting lines to properly record the deposit
  - InterUnit report is used to monitor transactions to ensure they stay in sync
- ▶ **Agency Interface Impacts**
  - Inbound Billing Data
  - Inbound Voucher Load

# Updates to Standardized BPM Office Hours

## Approach Change – InterUnit Functionality

- ▶ Key Process Activity 2
  - Revenue Transfers, Redistributions, and Reclassifications
- ▶ Agency Impact
  - Agencies process these transactions using a General Ledger Journal Entry
  - Revenue Transfer journal entries will workflow to the receiving agency to review their accounting lines
  - The invoice number will be the key element in processing redistributions and reclassifications related to interunit transfers
- ▶ Agency Interface Impacts
  - Inbound Journal Entry
- ▶ Process Model Reference
  - 10.2.1

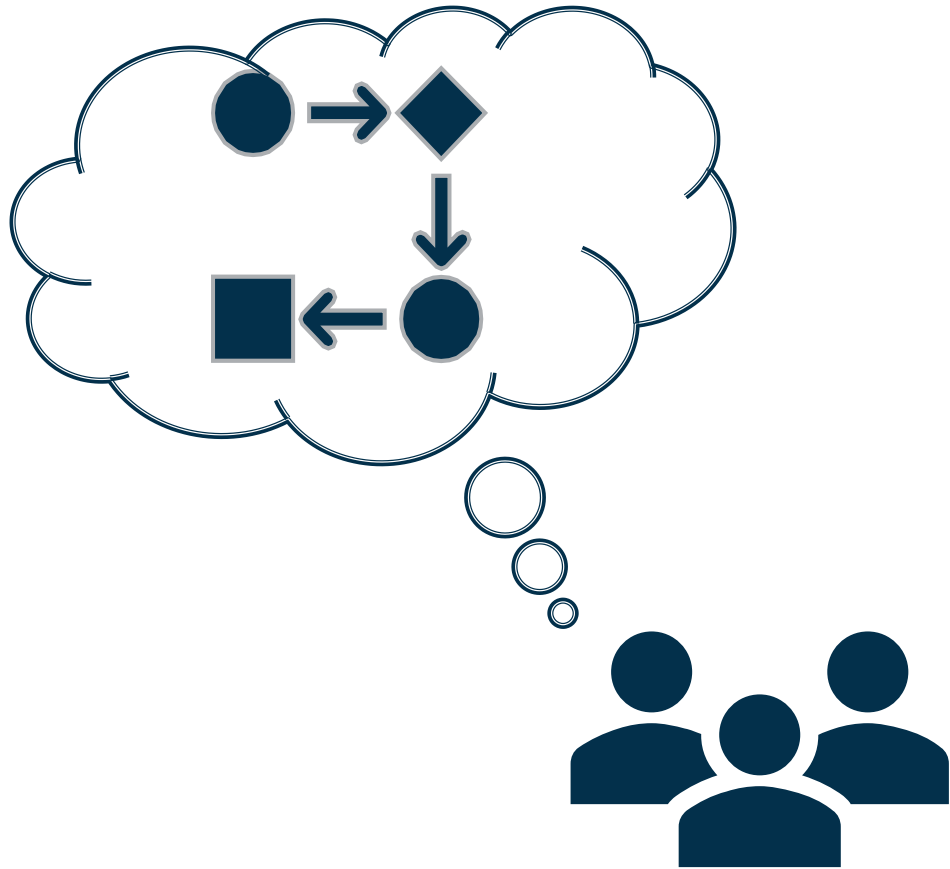

# Updates to Standardized BPM Office Hours

## Approach Change – Consolidated Revolving Funds

- ▶ Key Process Activity 1
  - Florida PALM automatically creates transactions for CRA activity from the bank statement to capture average daily balances for interest apportionment
- ▶ Agency Impact
  - Agencies do not enter deposits or payments in Florida PALM for CRA activity
  - Agencies continue to reconcile CRA activity outside of Florida PALM
- ▶ Agency Interface Impacts
  - N/A
- ▶ Process Model Reference
  - 80.2.7

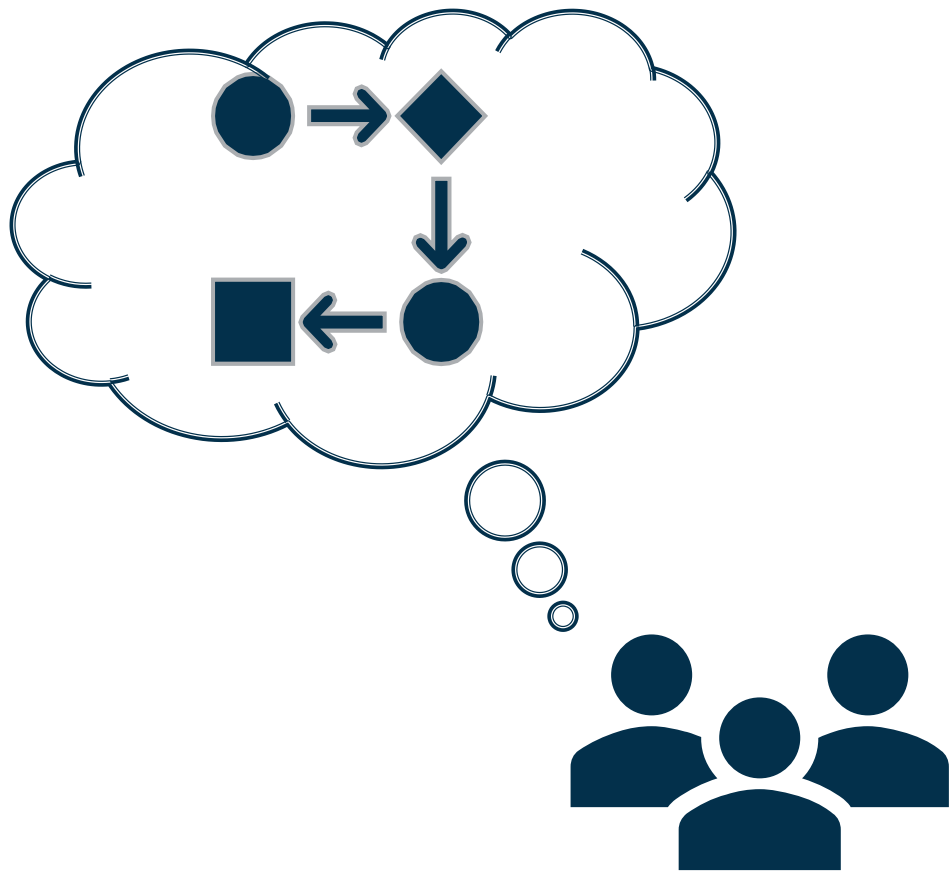


# Updates to Standardized BPM Office Hours

## Approach Change – Consolidated Revolving Funds

- ▶ Key Process Activity 2
  - Agencies complete the CRA Stop Payment Form to request cancellation of CRA payments
- ▶ Agency Impact
  - CRA Stop Payment Form is used instead of the AP Payment Cancellation form
  - Electronic form workflows directly to Treasury to stop payment at the bank
- ▶ Agency Interface Impacts
  - N/A
- ▶ Process Model Reference
  - 80.2.7
  - 30.5.4

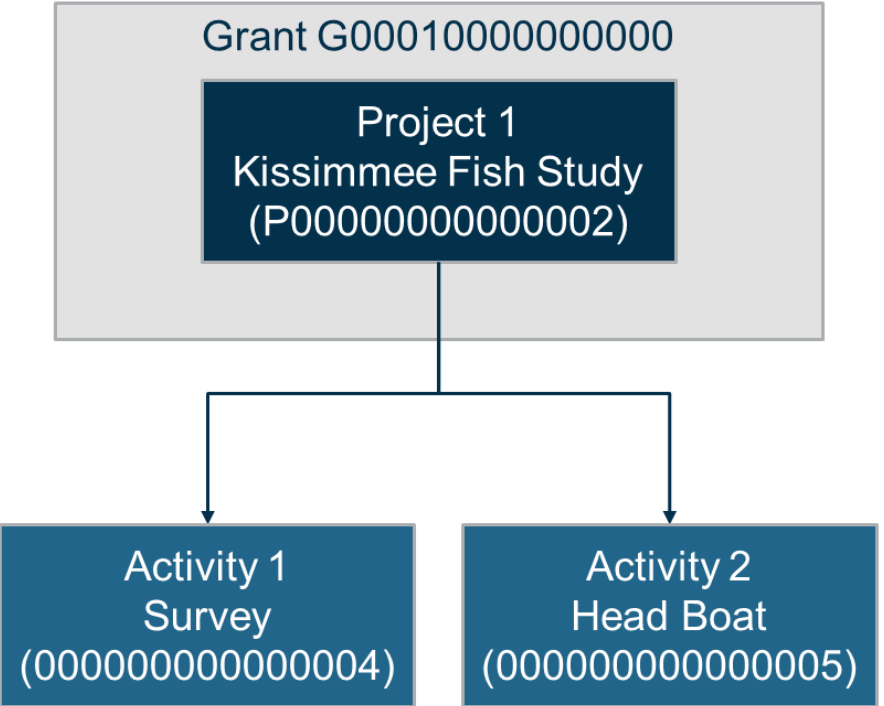

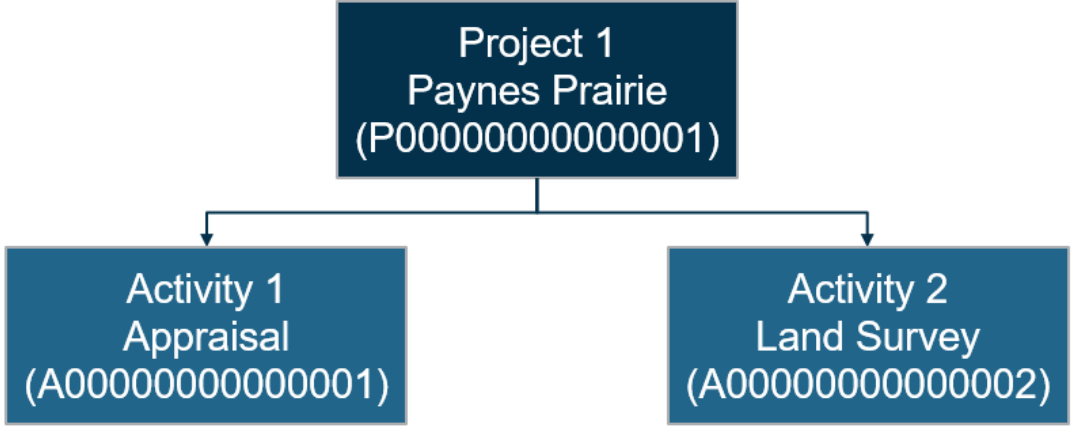

- ▶ Key Process Activity 1
  - Establishing the Project ChartFields
- ▶ Agency Impact
  - Use Florida PALM to request new CFDA/CSFA numbers
  - Tree functionality will provide association across Projects/Grants and roll up reporting
- ▶ Agency Interface Impacts
  - CFDA and CFSA Extract
  - Inbound Grant Details from FACTS/Agency Business Systems
  - Inbound Project Details from Agency Business Systems
- ▶ Process Model Reference
  - 10.1.4 Add Grant and/or Project Value



# Updates to Standardized BPM Office Hours

- ▶ Key Process Activity 2
  - Financial Monitoring and Closeouts
- ▶ Agency Impact
  - Agencies will perform monthly monitoring of Project and Grants financial status within Florida PALM
  - Agencies will perform closeout financial activities within Florida PALM
- ▶ Agency Interface Impacts
  - Inbound Grant/Project Details
  - Outbound Grant/Project Details
- ▶ Process Model Reference
  - 10.3.3 Grant/Project Financial Monitor and Closeout



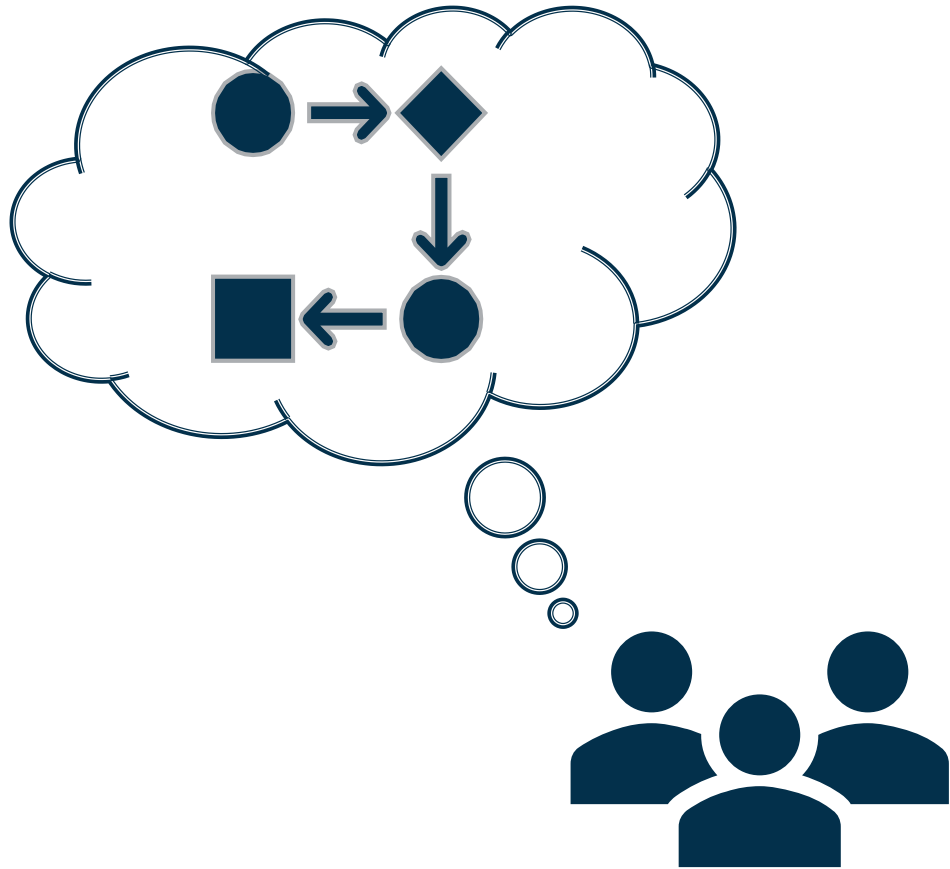
# Updates to Standardized BPM Office Hours

## Additional Information – Project and Grant Activities

- ▶ Key Process Activity 3
  - Fixed Capital Outlay (FCO) Certifications Process
- ▶ Agency Impact
  - FCO projects require a Project ChartField value
  - FCO Project budget must be regularly reconciled against appropriation budget
  - Requests for FCO Certification will be generated from the Projects module
  - Integrate into FCO Projects Worksheets generated through Commitment Control
- ▶ Agency Interface Impacts
  - N/A
- ▶ Process Model Reference
  - 10.3.3 Grant/Project Financial Monitor and Closeout
  - 20.3.2 Certified Forward

# Updates to Standardized BPM Office Hours

## Additional Information – Budget Activities

- ▶ Key Process Activity 1
  - Agency Allotments
    - Budgetary Fund - Used on budgetary transactions only to store appropriations, releases, and reserves budgets
    - Transactional Fund - Used to record financial accounting entries or budget entries for allotments
- ▶ Agency Impact
  - Transactional Fund is the mechanism to create and manage allotments
- ▶ Agency Interface Impacts
  - Inbound Budget Journals
  - Outbound Budget Extract Layout
- ▶ Process Model Reference
  - 20.1.2 Manage Agency Allotments
  - 20.3.1 Carry Forward

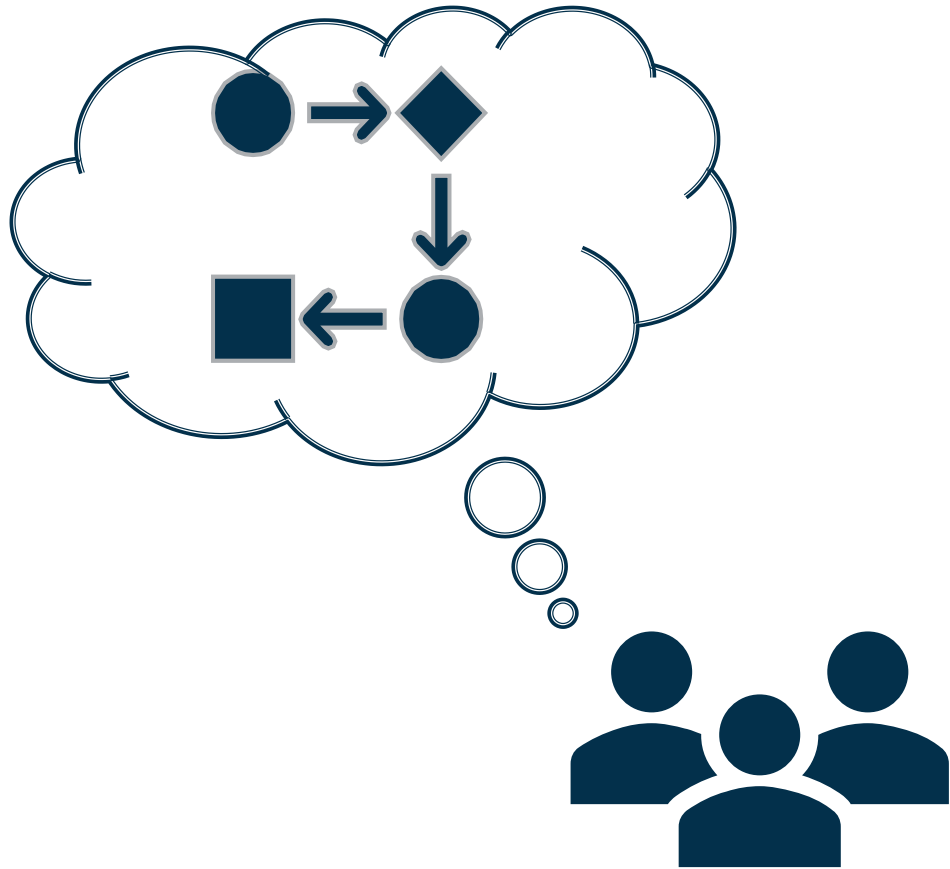

  - 80.1.1 Manage Cash Checking

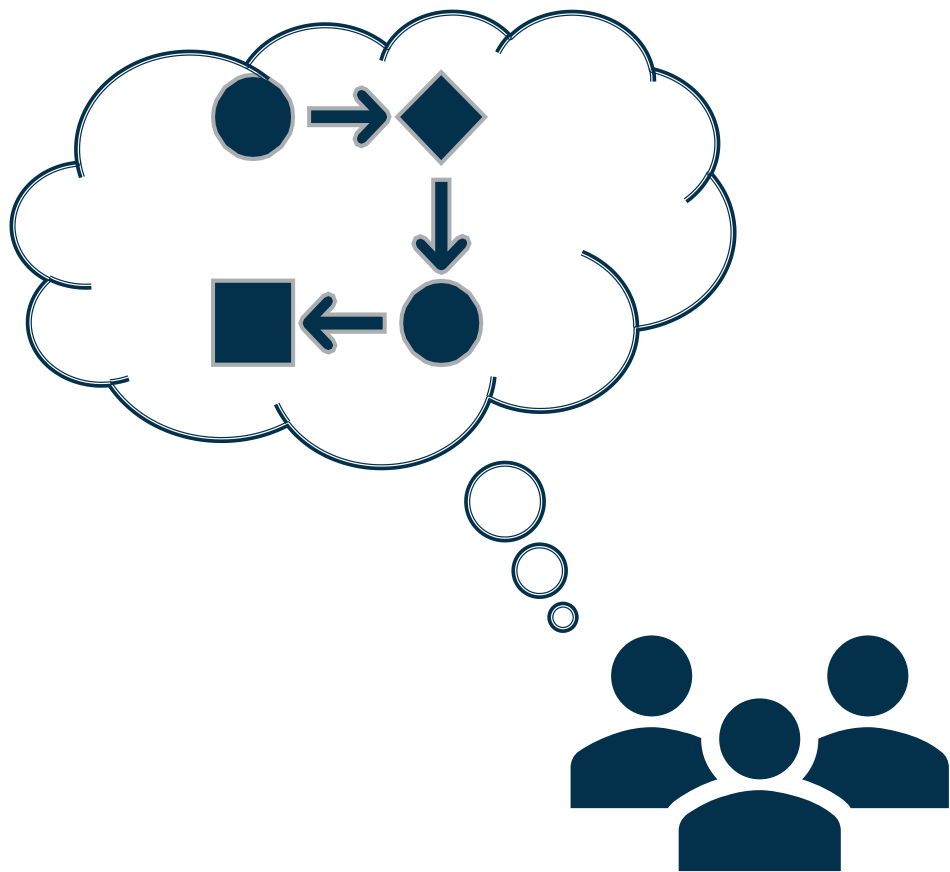


# Updates to Standardized BPM Office Hours

## Additional Information - Invested Balance Checking

- ▶ Key Process Activity 1
  - Invested Balance Checking
- ▶ Agency Impact
  - System process to confirm balances of invested funds prior to disinvesting
  - Electronic form with workflow allows request to DFS to override available invested balance exception, when appropriate
  - Introduced during CMS wave and will continue as end-state
- ▶ Agency Interface Impacts
  - N/A
- ▶ Process Model Reference
  - 80.1.2 Invested Balance Checking
