Task Overview

The Project Team will establish and lead a Reporting Workgroup for the Central and Departmental Waves made up of participants from representative agencies. Workgroup meetings are currently planned to occur once a month beginning in April 2021. Workgroup meetings will be used to:

- discuss agency reporting needs,
- demonstrate Florida PALM reporting tools and functionality,
- evaluate the Florida PALM Report Inventory, and
- share reporting samples.

Workgroup participants are expected to share this information within their agencies and may also be asked to provide input, complete surveys, and share updates with the Executive Steering Committee.





Reporting Overview

Florida PALM>Solution>Reporting: Reporting Approach

- Florida PALM is the book of record and source for all reports and data beginning at Departmental Wave. In the interim, reporting functionality and tools are available in Florida PALM for the relevant business processes.
- Florida PALM will support legacy reporting in Information Warehouse until Departmental Wave.
- Florida PALM will use links to legacy information for reports that use historical information.



Florida PALM Roles

- Enterprise and agency users access reports and data in Florida PALM.
- Users have access to reports applicable to their business processes
 & functions based on role assignments.
- Access to confidential information is limited to specific roles.
- Reporter roles are available for view only access.
- Query Writer Roles are available for agency-specific reporting needs.



Reporting Functionality

Self-service functionality is used to access information:

- Inquiry Pages
- Running a Query
- Running a Report
- Creating a Query
- Access to Data
 - Drilldowns
 - WorkCenters



Report Access, Scheduling, and Distribution

- Each user selects the relevant data parameters to run a query or report.
- Confidential information is masked or obfuscated to unauthorized users.
- The user can schedule a query or report.
- Results are sent to the user's Report Manager within Florida PALM for use or for saving and distribution within an agency's control environment.
- Reports are not sent as attachments or links to external users (pursuant to data security requirements).



Query Writer Expectations

- Access to data and tables is based on role security.
- The Agency Query Writer can share the query with others.
- Queries are performed using data in Florida PALM.
- Controls to reduce performance impacts:
 - Reports/queries can run for 15 minutes before being timed out
 - Joins allowed for up to 6 tables when creating queries



Types of Data Elements

- Reports and queries are available for the data elements used for Florida PALM operations. Data elements include:
 - Chart of Accounts
 - Related data elements (e.g., fund type, grant)
 - Status information (e.g., journals, vouchers, suppliers)
 - Transaction information (e.g., amounts, dates)
 - Reference Numbers (e.g., voucher, deposit, supplier ID)

Answers

- Users can access reports and information in Florida PALM relevant to their duties and security profile.
- Users can access information using online inquiries and drilldown to supporting information, as applicable. Dashboards and WorkCenters are new sources of information. Users may run or schedule queries and reports. Query writers can create and share queries using Florida PALM.
- Reports planned through 2024 are described in the Reports Catalog.
- Data elements used in Florida PALM are available for reporting. Key data elements are described for each report in the Reports Catalog.





Reporting Functionality

- Self-service reporting functionality and tools are available to users in Florida PALM based on role assignments. <u>Video demonstrations</u> are available for inquires, queries and reports in Florida PALM.
- As described in the Reporting Approach, Florida PALM will support legacy reporting until Departmental Wave. Florida PALM will use links to legacy information for reports that use historical information.

Data Elements

- The Reports Catalog includes a description and the key data elements for each planned reports.
- Data elements used in Florida PALM operations can be accessed for reports and queries.
- The Agency Query Writer can create queries using the data elements used in the various business processes. Access to data and tables are based on the user's assigned role(s).




Figure 2: Florida PALM ChartField Mapping

Answers

Reporting needs were identified as part of the business process design and as identified in ESC-approved requirements. Agency feedback provided throughout the process is considered in designing specific reports, and identifying reports needed by business process.



Answers

The Florida PALM reports will be different from the legacy reports due to differences in business processes and data structure. An analysis of the reporting needs represented by legacy reports is completed for each Wave, by the Project with feedback from agencies in the Reporting Workgroup, to evaluate whether the Florida PALM reports provide information needed by agencies and other users.



Business Process & Transaction Analysis



- Who can access reports in Florida PALM?
- How does my agency satisfy unique reporting needs?





- Users in Florida PALM can access reports applicable to the business processes for each role and based on security.
- Agencies may identify users as the Agency Query Writer to write agency-specific queries. This role can access Florida PALM data, applicable to the agency, for creating and sharing queries.



Role Access to Information and Data

- Roles are available to enterprise and agency users to access reports and information in Florida PALM.
 - Users can access the reports in their relevant module.
 - Reporter View-only role to access reports by Module
 - Query Writer Role to create queries for agency-specific needs and sharing with other users

- How can information be viewed or exported?
- How will legacy information be accessed?
- Will business intelligence (BI) tools be available?
- When are BI tools used in lieu of other reporting tools?



- Information can be viewed in Florida PALM or exported using a variety of format types.
- Legacy information will be maintained in the Information Warehouse and maintained in accordance with record retention requirements. Florida PALM will include links to legacy information for use in specific reports that require multiple years of data, until such information is accumulated in Florida PALM.
- The use of BI tools is planned for some reports. Most operational reports do not require the use of BI tools. BI tools are used for certain analytical reports that require complex logic.



- <u>Reports</u> is an umbrella term for various form of data/information provided by the financial solution for internal/external users. It encompasses all formatted/unformatted data to consume, such as formatted printed reports, result of database query, data extracts, etc.
- **Query** is a reporting tool used to perform operational reporting. It allows the user to use prompts, expressions, criteria, to retrieve selected data from the database.



- Inquiry is for the most immediate information needs that are met by viewing the data on a page in Florida PALM. Inquiry pages allow users to search for transactional information in real-time, see the results online, and download data to offline, if needed.
- <u>Drill down</u> is a capability to see all the relevant details from top summary level to the lowest raw data level. This drill down capability can be found in various places such as in reports, inquiry pages, dashboards, etc.

Reporting Workgroup


- Dashboard is a type of graphical user interface which often provides at-a -glance views of key performance indicators relevant to a particular objective or business process to a particular user.
- <u>Data Extract</u> is a discrete file created with data obtained by executing a query or running a report. Agencies may choose to retain existing external reporting platforms by taking advantage of data extracts. The Solution will make data extracts available through the Florida PALM interface approach.




• <u>Business Intelligence (BI)</u> comprises the strategies and technologies used by the enterprise for the data analysis of business information. Business Intelligence technology provides historical, current, and predictive views of business operations. Business Intelligence leverages software to transform data into actionable insights that inform an organization's business decisions.

Functional Breadth



- How do I run a report?

- End-user training describes the steps for how to use Florida PALM and the available reporting tools. Additionally, navigational information is included in the Reports Catalog
- End-user training for reporting is now available in Peoplesoft Learning Management System. Training is offered before each Wave implementation for the applicable business processes.

- Will detail transaction data remain available in Florida PALM after each yearend?
- Will agencies have limits on accessing data?



- Transaction data will remain in Florida PALM and be available for reporting on an on-going basis. Each module includes details for operations for the relevant business processes. These activities are summarized and posted to the General Ledger.
- In the legacy environment, data was off-loaded for use in the Information Warehouse or other external tools.



- Can my agency schedule and distribute reports as is done in the legacy environment?
- How will casual users access reports?



- Users with roles in Florida PALM can run or schedule queries/reports. Results are sent to the user's Reporting Manager page in Florida PALM. The report can be created in multiple formats (i.e., PDF, Excel) and saved by the user for external use.
- Agencies may choose to assign Reporter roles to casual users. The Reporter roles allows view only access to queries and reports and offers the most up-to-date information. Alternatively, agencies may choose to save reports outside of Florida PALM for email or other distribution to users. Agencies are responsible for creating an appropriate control structure to distribute reports which include sensitive information.

- When will reports used for managing payroll be added to the Reporting Catalog?
- When will the Reporting Workgroup discuss reports for Departmental Wave? For Payroll Wave?



- Design activities are on-going for Payroll Wave. When these activities are completed and business process models are approved, payroll reports will be added to the Reports Catalog.
- The Reporting Workgroup will review Central Wave Reports and Departmental Wave reports in 2021.
- A new Reporting Workgroup will be created to review Payroll Wave reports in 2022.
