

Payroll Module Configurations

This workbook contains multiple worksheets, for applicable agencies, that represent core configurations in Florida PALM and/or People First. Column/Field definitions and instructions are provided below. This configuration workbook contains the following Payroll (PR) module configuration for which agencies will review and update (as needed) the values that will be set up in Florida PALM:

- Firefighter Incentive Pay (FFIP) Funding

NOTE: The FFIP configuration values are only required from select agencies whose employees currently receive those types of payments.

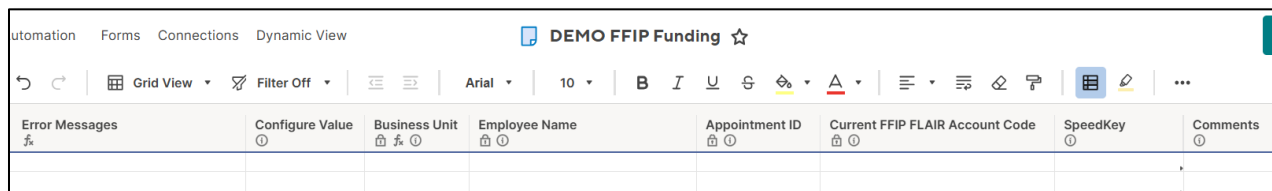

Ongoing Data Update and Refresh Timeline

Agencies must maintain conversion and configuration (“convergeration”) related workbooks, as they will be used to support the Project performed Dry Runs and final Cutover as shown in the [Testing Timeline](#). A detailed Convergeration Schedule will be published upon completion of the Project’s Amendment 13 schedule updates. The Convergeration Schedule will provide dates that worksheets will be refreshed with new data from FLAIR and when the Project will export values from worksheets to support Dry Run and Cutover activities.

Configuration Value Definition

FFIP Funding is used to assign funding to payments related to FFIP. All active employees with this recurring payment in People First must have a valid FFIP SpeedKey created in Florida PALM and assigned in People First. FFIP Funding is only relevant to agencies who have employees that receive FFIP.

NOTE: The FFIP Funding configuration workbook is only required to be completed by the following agencies: DACS, DFS, DMA

Business Process and Subprocess

The FFIP Funding configuration supports the following business process and subprocess:

Configuration Value Purpose and Use

- The FFIP Funding configuration provides agencies an initial load and set up of their funding information for employees who receive FFIP in People First.
- Eligible SpeedKeys for FFIP are being collected and transmitted to People First for initial load. These will be provided on the applicable earnings and will override funding distributions in Florida PALM.

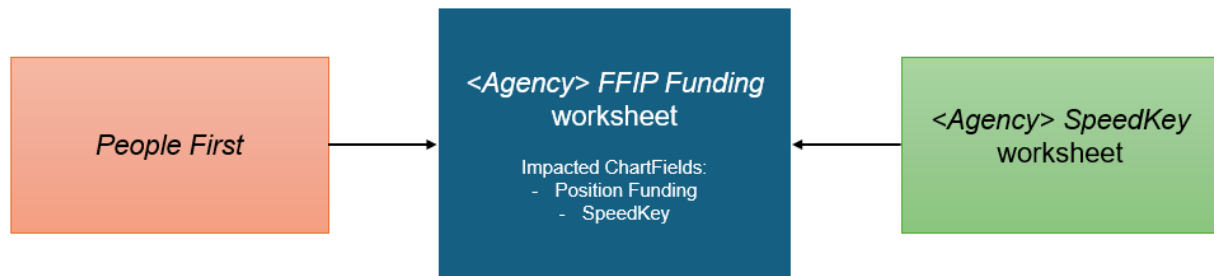


Figure 2: Cross-worksheet Connections for FFIP

The ChartField values that are being utilized in the FFIP Funding worksheet are sourced from a related agency worksheet (Figure 2) to ensure the most current information is available in associated ChartField drop-down selections as you complete your agency's configuration workbooks.

Failure to complete the <Agency> SpeedKey configuration worksheet will result in SpeedKey ChartField values being unavailable for selection by your agency in the Payroll configuration worksheets.

Configuration Design Details

The following design considerations are applied when defining an employee's FFIP Funding in Florida PALM:

- The SpeedKey must be valid in Florida PALM to be assigned to the employee's FFIP payment in People First.
- The SpeedKey must be marked eligible for payroll use to be assigned to the employee's FFIP payment in People First.
- The SpeedKey must be eligible for the payment type (e.g., payment type must not be for OPS payments).
- FFIP SpeedKey will be stored and updated on the employee's FFIP record in People First after initial load.

Assumptions

The following assumptions are considered when defining an employee's FFIP Funding:

- The employee that FFIP Funding is being assigned to exists in Florida PALM.
- The employee that FFIP Funding is being assigned to belongs to the Business Unit provided.
- The employee receiving the FFIP Funding has an active recurring payment for FFIP in People First.

Configuration Field Details

Agencies must provide the following Firefighter Incentive Pay Funding related configuration values as listed in the <Agency> FFIP Funding worksheet in Smartsheet.

Worksheet Instructions

The below information provides detailed instructions on how to complete the <Agency> FFIP Funding workbook. Continue to update FFIP Funding for your agency as needed.

- Review the worksheet and determine whether the configured values need updating in Florida PALM. A *Configure Value* column is provided to capture your agency's determination of the disposition of a configured employee that receives FFIP Funding. Indicate "Yes" or "Update" as appropriate.
- In the *Configure Value* column:
 - Select "Yes" to confirm the configured employee is correct and no updates are needed.
 - Select "Update" to update the configured SpeedKey. For example, if there is red text, it indicates that the current SpeedKey value is no longer valid based on your current <Agency> SpeedKey worksheet. You will mark Configure Value as "Update" and update the corresponding items.
 - Select the desired SpeedKey value your agency would like assign to the employee's recurring FFIP payment in People First.
 - The SpeedKey must be eligible for Payroll use and for the employee type (e.g., payment type must not be for OPS payments).
 - If the SpeedKey cell turns purple, review the error message.
 - SpeedKey updates or additions that have been made in your <Agency> SpeedKey worksheet will appear for selection in your <Agency> FFIP Funding worksheet via overnight processing.
- Review and correct any errors identified in the *Error Messages* column.
- Use the Comments field, optionally, for your internal purposes.
