- Profile ID's Trigger Automatic Creation of Asset Records n the Florida AM Module
 - Change Asset Attributes After Asset Records Are Created

 - Asset transactions can be reviewed, prior to being processed
 - Asset Attributes may be changed
 - Payment Data cannot be changed
- Profile ID's drive creation of Asset Records
 - o Incorporate functionality of current Cost Codes
 - Input on the Vouchers
 - May be changed up until voucher is processed
 - Profile ID locked after Asset Record is created
 - Changes will need to be made in the Asset Book
 - Asset Book houses the Depreciation Profile

Asset Management Source of Asset Vouchers

- Florida PALM Encumbrance Vouchers (online entry) and Encumbrance Vouchers from MFMP and ABS (Interfaces)
 - Asset Related Item Category used to create Encumbrance
 - Voucher created from Encumbrance automatically populate Asset Information
- Non-Encumbrance Vouchers from MFMP and ABS (Interfaces)
 - Interface Layout requires Asset Information
- Non-Encumbrance Vouchers entered directly into Florida PALM (Online AP entries)
 - Users required to enter Asset Information





NOTES:

- Asset Records created automatically based on specific criteria when vouchers are integrated from Accounts Payable to Asset Management
- Indicators such as Item Category, Account Code and Profile ID trigger the voucher for selection to create an asset

- Florida PALM Encumbrance Vouchers (online entry) and Encumbrance Vouchers from MFMP and ABS (Interfaces)
 - System cross-walk MFMP Commodity Code to Florida PALM Item Category
 - System identifies and selects Asset Related Vouchers based on Item Category
 - Item Category determines Asset Related Account Code
 - System selects Profile ID (FLAIR Cost Codes translated to produce Florida PALM Profile ID's)
 - Profile ID's based on Usage History (Default values based on most frequently used FLAIR Cost Codes)
 - Profile ID's Provide Depreciation Attributes needed to automatically create Asset records in Florida PALM





NOTES:

- Asset Records created automatically from vouchers resulting from Encumbrances through online entry, MFMP or agency business systems.
 - o Florida PALM verifies combination of Item Category and valid Account Code
 - A default Profile ID is created or changed in the Staging Table, which automatically create the Asset record
