# Important Design Notes

- ▶ Build has already started → design is completely locked for those items

# Cutover Considerations

- ▶ Cutover discussions are just beginning! → A lot of information to come, all will be known and shared at the end of Design Segment IV
- ▶ Mid-year closing will have to occur to support cutover from FLAIR to Florida PALM
- ▶ Conversions will generally be balances, not transactions
- ▶ Historical transactions, including transactions for FY 25-26 will not be converted to Florida PALM, their results (balances) will be converted
- ▶ Plan is to start UAT with a simulated mid-year cutover for FY 24-25

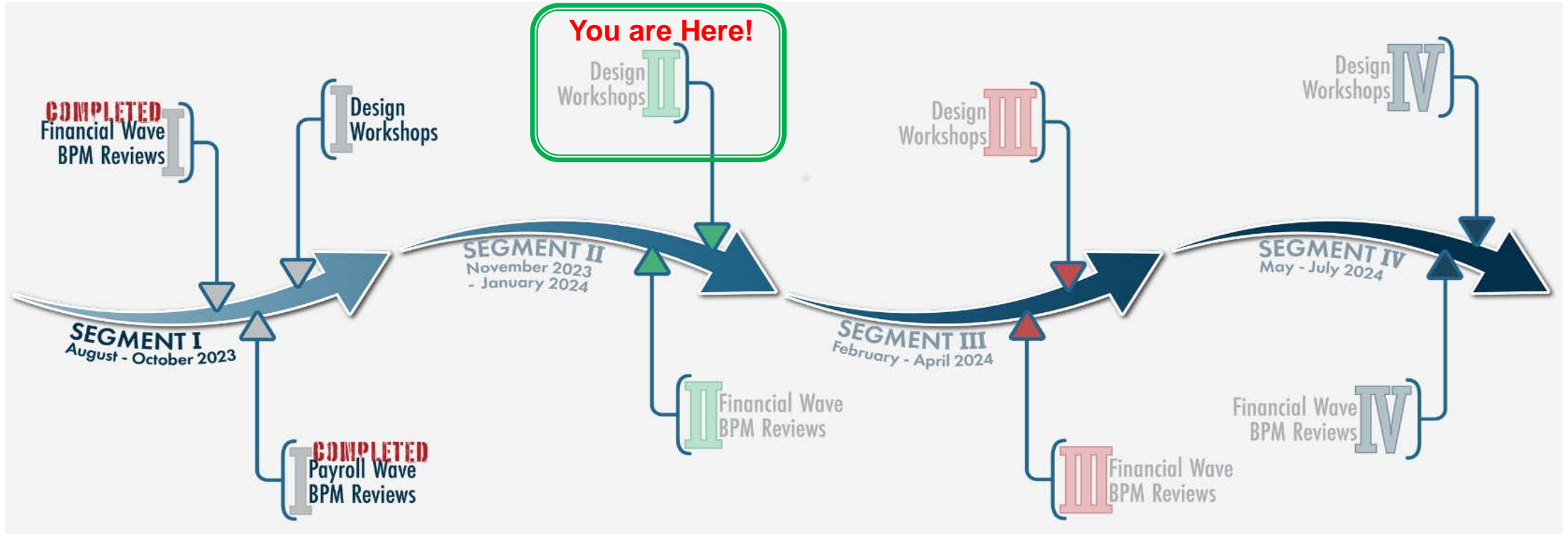

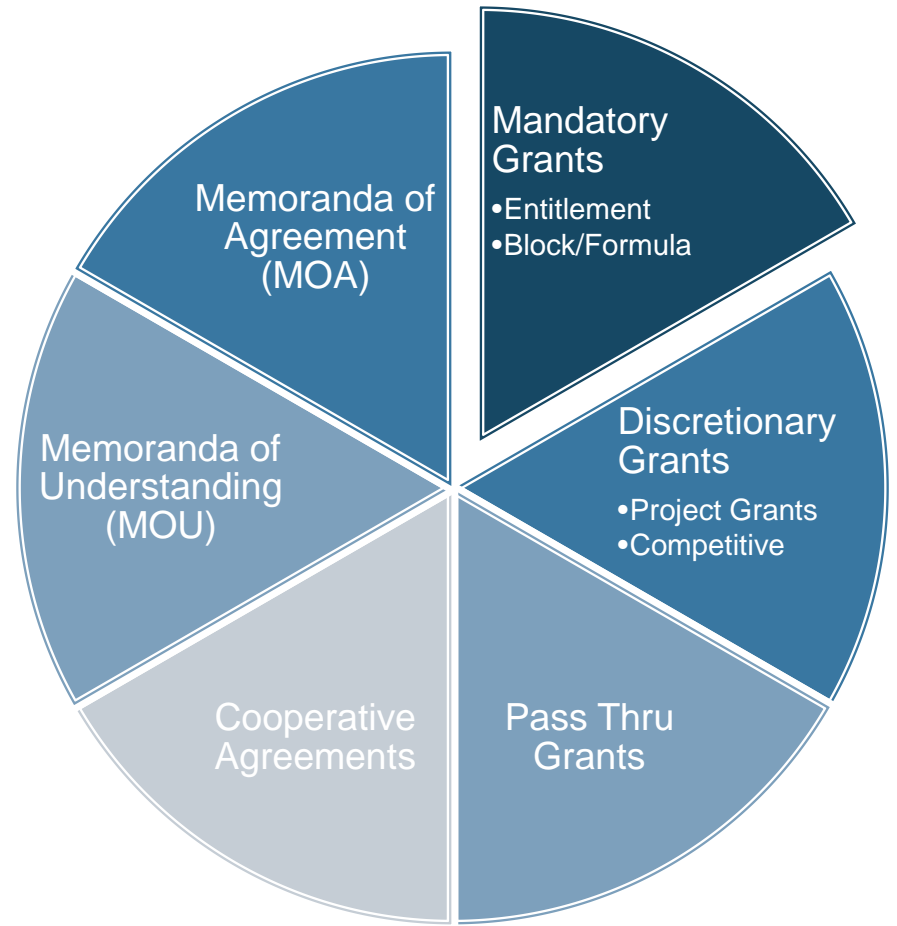


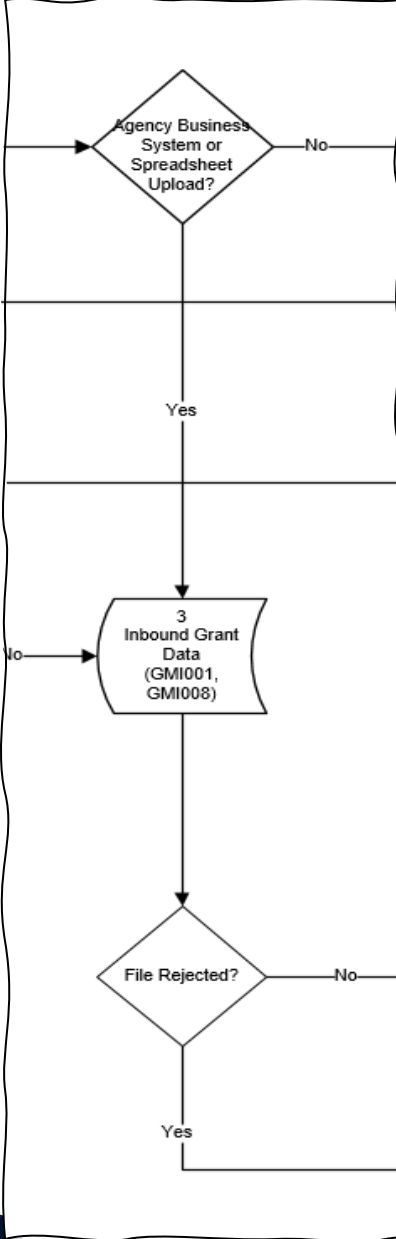


**215.985 Transparency in government spending.—**

- (1) This section may be cited as the “Transparency Florida Act.”
- (2) As used in this section, the term:
  - (a) “Committee” means the Legislative Auditing Committee.
  - (b) “Contract” means a written agreement or purchase order issued for the purchase of goods or services or a written agreement for the receipt of state or federal financial assistance.

**Grant** - Receipt of financial assistance from the Federal Government, State or Local Government, non-profit or for-profit entity or individual, by any official, officer, commission, board, authority, council, committee, or department of the executive or legislative branch of state government.

## Florida Single Audit Act

The Florida Single Audit Act, Section 215.97, Florida Statutes, establishes state audit and accountability requirements for state financial assistance provided to nonstate entities. The Legislature found that while federal financial assistance passing through the state to nonstate entities was subject to mandatory federal audit requirements, significant amounts of state financial assistance was being provided to nonstate entities that was not subject to audit



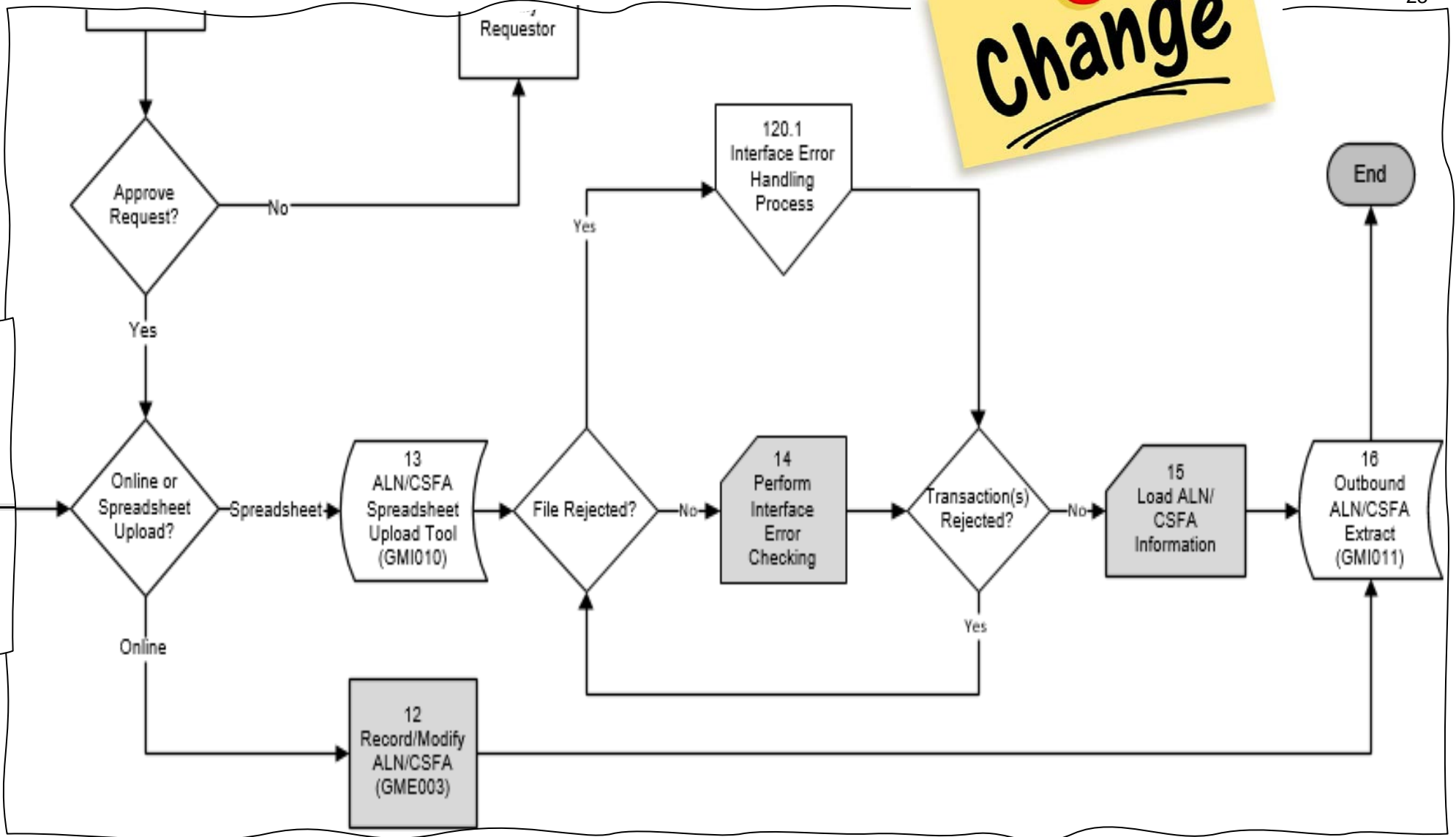
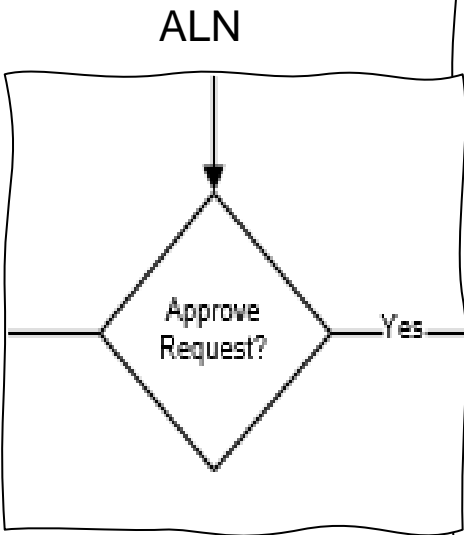
