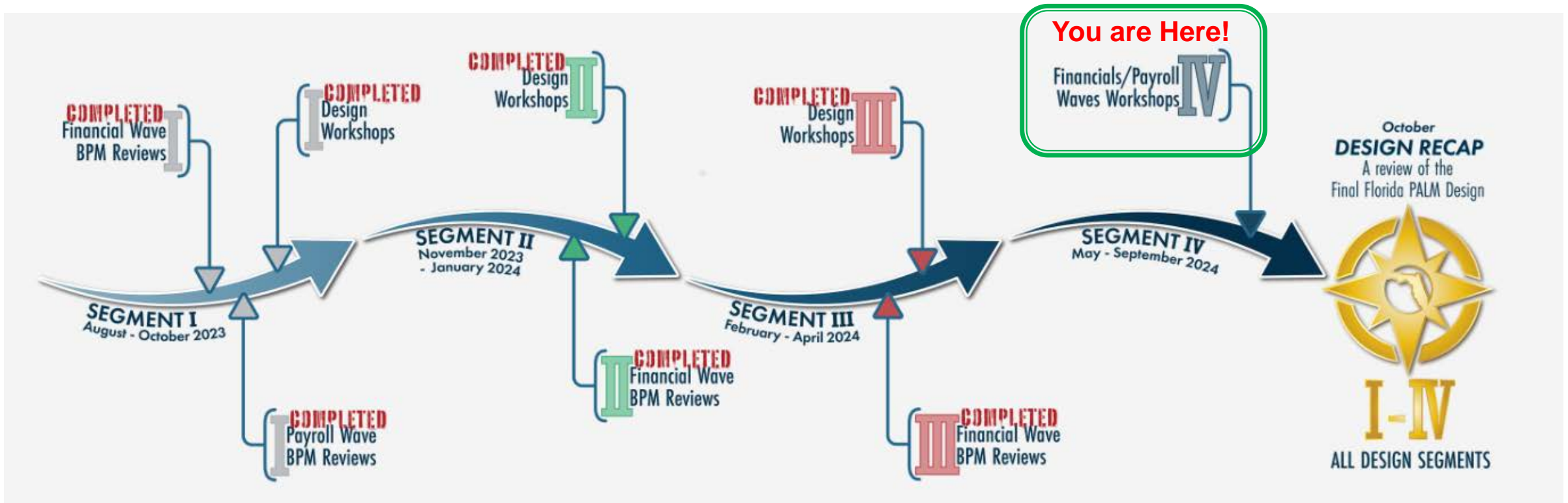

PRE-PERIOD CLOSE – PREPARING FOR AM
MONTH-END CLOSE



Pre-Period Close

Pre-Period Close Criteria

- ▶ Florida PALM will not perform period close (end of month or end of fiscal year) in the Asset Management (AM) module
- ▶ Florida PALM will perform period close (end of month and end of fiscal year) in the General Ledger (GL) module
- ▶ Users will take steps to prepare AM for period close prior to the process which will be performed in GL
- ▶ Pre-Period activities in AM includes completing all transactions initiated in the period
- ▶ Incomplete transactions will not be processed in the current period
- ▶ Only processed transactions will be recorded in the current period

RECORDING WIP TRANSACTIONS



Work in Progress

WIP Criteria

- ▶ Work in Progress (WIP) transactions will originate from Fixed Capital Outlay (FCO) disbursements
- ▶ WIP transactions will be processed in Accounts Payable (AP) and integrated into Asset Management (AM)
- ▶ All WIP related vouchers will include a Project ID
- ▶ All WIP related vouchers should include the NONDWIP Profile ID
- ▶ The initial WIP related voucher will create a unique Asset ID
- ▶ Florida PALM will process all WIP transactions that appear on the Staging Table with “Next” or a valid Asset ID, and group the transactions according to the Asset ID values
- ▶ WIP transactions will be recorded as Non-Depreciable assets in AM
- ▶ Groups of WIP transactions will be capitalized under the original Asset IDs at project completion

Subsequent Voucher Criteria & Corrections

- ▶ Users should use the original Florida PALM generated Asset ID to record subsequent transactions related to a WIP project
- ▶ Florida PALM will group WIP transactions based on Asset ID
- ▶ Transactions unintentionally entered without an existing Asset ID will be recorded with a new Florida PALM unique Asset ID
- ▶ If the error is detected before the transaction is processed in AM, the user can “delete” the transaction, input an online cost transaction, and reference the originating AP Voucher ID
- ▶ If the error is detected after the transaction is processed in AM, the user can “retire” the asset, and input an online cost transaction on the original Asset ID and reference the originating AP Voucher ID

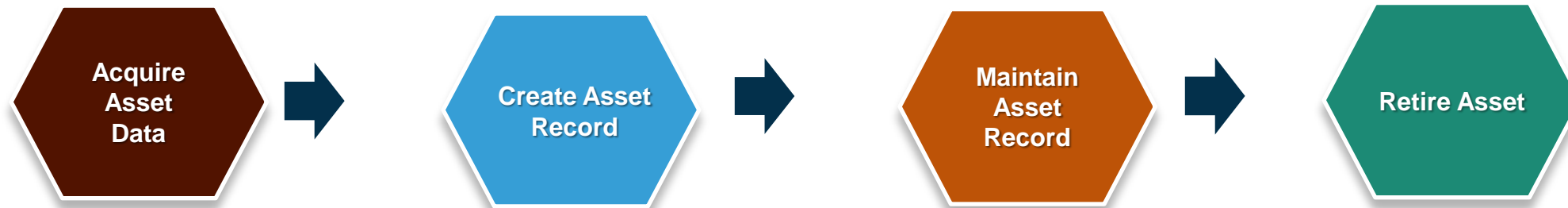

- ▶ Governmental Fund must have a corresponding Ownership Fund that records fixed asset purchases associated with a Governmental Fund
- ▶ Allocation process is a mechanism used to reclassify Governmental Fund purchase of fixed assets to a related Ownership Fund
- ▶ There can be one or multiple Governmental Fund(s) associated with an Ownership Fund
- ▶ A Governmental Fund cannot be associated with more than one Ownership Fund
- ▶ The Florida PALM allocation process will take place in the General Ledger (GL) module



Accounting for Governmental Fund Assets

Create Reclassified Entries in GL

- ▶ Develop a GL Allocation to reclassify entries from Governmental Fund to Ownership Fund based on AM accounting entries after they have been journal generated and posted to the GL

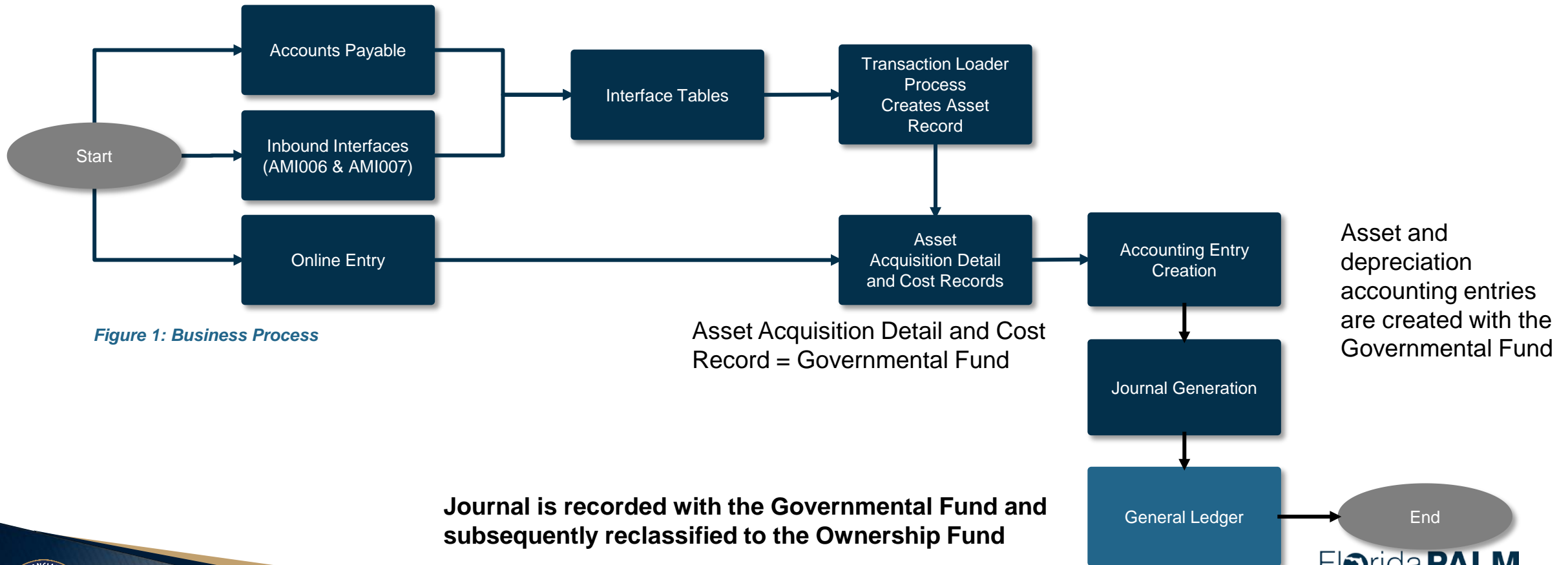


Figure 1: Business Process
