Background (Describe the contributing factors and events which lead to the identification of the issue)	The Executive Steering Committee (ESC) vote for Stage Gate 3 - Ready to Begin UAT was scheduled to occur during the monthly ESC meeting on July 30, 2025. However, the vote was postponed, due to several factors, until a date to be determined. The delay in voting resulted in a delay in the start of UAT, which, per the Florida PALM Project Schedule, was scheduled to begin on August 11, 2025. The Project was behind in several areas resulting in a failure to meet the criteria listed in Table 3 in the Software and System Integrator (SSI) contract's Attachment 1 – Statement of Work. The following criteria should be met before the Project may be considered ready to begin UAT: • Design and build are complete • Contractor system test is at least 90% complete or as mutually agreed to • The UAT environment is ready for testing Subsequent to the July 30 ESC meeting, the Stage Gate 3 criteria have been completed or substantively completed for Financials and Payroll but remain incomplete for the Data Warehouse/Business Intelligence (DW/BI). Additionally, the Project was made aware that the version of PeopleTools the Project currently uses will expire 9-months after the planned go-live of July 2026. This does not provide sufficient

	software provider, confirmed that any fixes/enhancements that are dependent on the newer PeopleTools version would not be provided for the older version. Going unsupported could open the system to security vulnerabilities. As a result, the Project is reviewing to determine the impacts to UAT on updating to the latest version of PeopleTools.
	In addition, most agencies reported they were somewhat ready for UAT, with only a few reporting they were ready for UAT. In their July Monthly Report, the Florida PALM IV&V Team "observed that some Agencies may not be ready for UAT based on incomplete RW Tasks that are past due, reported staffing shortages, and insufficient UAT and Training plans."
