

Agency Business Systems Functionality Profile for <AGENCY>

Purpose

Pursuant to Section 6, Appropriation 2317A of the 2016 General Appropriations Act, the Department of Financial Services has contracted with a third party consulting firm to complete the business case for maintaining any of the agency business systems identified in Attachment 2 of the March 31, 2014, Florida Department of Financial Services FLAIR Study, version 031, after the FLAIR subsystem and the CMS are replaced. The Department is required to submit the business case to the Executive Office of the Governor, the President of the Senate, and the Speaker of the House of Representatives no later than November 1, 2016.

The purpose of this Agency Business System Functionality Profile (the "Profile") is to, and accordance with Section 6, Appropriation 2317A of the 2016 General Appropriations Act, provide a detailed description of the functionality provided by agency business systems, including federal and state law, rule, or policy, which validates that the agency is required to maintain the functionality currently provided by the agency business system.

- 2) Select "(move to end)", click the checkbox "Create a copy", and click OK.
- 3) Name the tab by double clicking the new tab and typing the acronym of the business system.
