DIRECTIONS

From the Orlando International Airport: Follow State Road 436 North 19 miles until you see signs stating you are approaching Altamonte Springs. The first land mark to look for is the Altamonte Mall on your right, after passing the mall, continue approximately three traffic signals to Cranes Roost Boulevard (Look for the entrance to Uptown Altamonte). At Cranes Roost Boulevard turn right, make your first left onto Shorecrest Drive. The hotel entrance will be on your right.

You can also take State Road 436 to the East-West Expressway, which is State Road 408. Take S.R. 408 West to Interstate 4. Take I-4 East to exit #92, which is State Road 436, Altamonte Springs. Turn right onto S.R. 436. Go to the first traffic signal, Cranes Roost Boulevard (Look for the entrance to Uptown Altamonte) and turn left, make your first left onto Shorecrest Drive. The hotel entrance will be on your right.

From Northwest Florida: Take Interstate 75 South to Florida's Turnpike. Follow Florida's Turnpike South to State Road 408 (East-West Expressway). Take SR-408 East to I-4. Take I-4 East to exit #92, which is State Road 436, Altamonte Springs. Turn right onto S.R. 436. Go to the first traffic signal, Cranes Roost Boulevard (Look for the entrance to Uptown Altamonte) and turn left. Follow Cranes Roost Boulevard for about 500 feet make a left onto Shorecrest Drive. The hotel entrance will be on your right.

<u>From South Florida</u>: Take Interstate 95 North to the BeeLine Expressway, which is State Road 528. Head West on the BeeLine to Interstate 4. Take I-4 East to exit #92, which is State Road 436, Altamonte Springs. Turn right onto S.R. 436. Go to the first traffic signal, Cranes Roost Boulevard (Look for the entrance to Uptown Altamonte) and turn left. Follow Cranes Roost Boulevard for about 500 feet make a left onto Shorecrest Drive. The hotel entrance will be on your right.

You can also take Florida's Turnpike North to I-4. Take I-4 East to exit #92, which is State Road 436, Altamonte Springs. Turn right onto S.R. 436. Go to the first traffic signal, Cranes Roost Boulevard (Look for the entrance to Uptown Altamonte) and turn left. Follow Cranes Roost Boulevard for about 500 feet make a left onto Shorecrest Drive. The hotel entrance will be on your right.

<u>From Tampa</u>: Take I-4 East to exit #92, which is State Road 436, Altamonte Springs. Turn right onto S.R. 436. Go to the first traffic signal, Cranes Roost Boulevard (Look for the entrance to Uptown Altamonte) and turn left. Follow Cranes Roost Boulevard for about 500 feet make a left onto Shorecrest Drive. The hotel entrance will be on your right.

<u>From Jacksonville</u>: Take I-95 South to I-4. Take I-4 Westbound to Exit #92, which is State Road 436, Altamonte Springs. Turn left on S.R. 436. Go to the second traffic signal, Cranes Roost Boulevard (Look for the entrance to Uptown Altamonte) and turn left. Follow Cranes Roost Boulevard for about 500 feet make a left onto Shorecrest Drive. The hotel entrance will be on your right.
