## Direct Disposal Establishment Instructions for licensure

- A. Complete the application located on the Division's website at <a href="http://www.myfloridacfo.com/Division/funeralcemetery/Licensing/documents/DFS-N1-1757.pdf">http://www.myfloridacfo.com/Division/funeralcemetery/Licensing/documents/DFS-N1-1757.pdf</a>.
- B. Complete the Business Entity-List of Principals Form located on the Division's website, http://www.myfloridacfo.com/Division/FuneralCemetery/fc forms 2012/pdf/DFS-N1-1718.pdf.
- C. Fingerprint card submissions for each officer, owner, manager and/or director. Payment for processing can be made at <a href="https://www.identogo.com/">https://www.identogo.com/</a>. As a State of Florida resident, follow the prompts on the website to locate a site to have the fingerprints taken electronically. For non-Florida residents, follow the directions at the aforementioned website in order to pay for the processing and have the fingerprint cards sent.
  - a. Please note section 497.142(11)(a), Florida Statutes, which provides,
    - (11)(a) When an applicant is required by this chapter to submit fingerprints in applying for a license, the following persons shall be required to submit such fingerprints:
      - 1. Where the applicant is a natural person, the fingerprints of the natural person making application.
      - 2. Where the applicant is a corporation, the fingerprints of the persons serving in the following capacities: chief executive officer and president, or both persons if the positions are filled by different persons; chief financial officer; chief of operations; general counsel if a corporation employee; and members of the board.
      - 3. Where the applicant is a limited liability company, the fingerprints of all managers and members of the limited liability company.
      - 4. Where the applicant is a partnership, the fingerprints of all partners.
- D. If the Direct Disposal Establishment will be contracting any services out (i.e. embalming, refrigeration, storage or transportation of bodies), a copy of each contract must be submitted. Each contract must include the Name of the Establishment, License Number, Address and be signed by the Funeral Director in Charge or Owner.
- E. If the establishment is a Corporation or LLC or has a Fictitious Name, such names must be filed with the Department of State (<a href="www.sunbiz.org">www.sunbiz.org</a>) and a copy of the certificate must be submitted with the application.
- F. Provide a course completion slip for a two-hour Communicable Disease Course by an approved Florida Provider. To find a list of continuing education providers, please contact the Division at 850-413-3039 and one can be sent to you.
- G. Please see rule 69K-23.004, Florida Administrative Code, regarding the further requirements.
