# DIFS' Bureau of Insurance Fraud Arrests 12 People Involved in a \$42.7 Million Insurance Fraud Ring

DIFS fraud detectives revealed that 14 individuals submitted 23,708 claims to insurance companies, containing over 20 different physicians' stolen identities for fraudulent services from 2015 to 2018. Claims were listed as originating from 15 "phantom clinics" with addresses in the Fort Myers, Tampa, Lake Worth, Boca Raton and Miami. These fake clinics had physical addresses to function solely as drop boxes for insurance payments. In total, \$42,742,852 in fraudulent medical claims were submitted to insurance companies for payment.

At a press conference in Ft. Myers on February 6th, Chief Financial Officer (CFO) Jimmy Patronis announced the arrest of 10 individuals that were involved in the insurance fraud ring. Two of the outstanding participents were later found and obtained with one turning himself in to law enforcement officials. Two participants are still outstanding including Jorge Valido, a former Miami doctor and primary figure in the fraud scheme, along with Minerva Valido.


