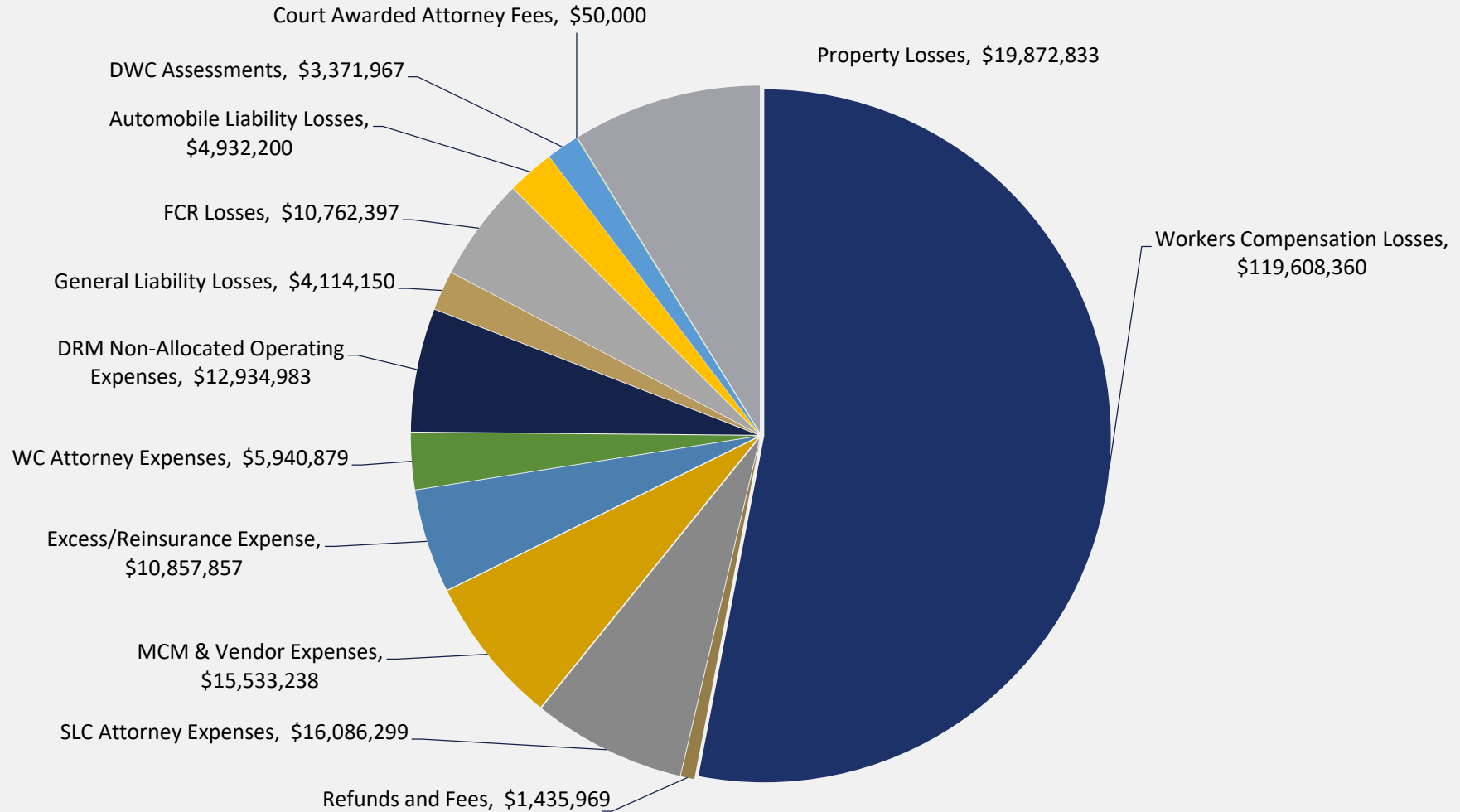
Program Highlights

- Workers' Compensation claim costs increased by \$10.8 million compared to FY2016/2017.
- Liability claim costs decreased by \$1.4 million compared to FY 2016/2017.
- FCR claim costs decreased by \$6.7 million compared to FY 2016/2017.
- Property claim costs increased by \$16.1 million compared to FY 2016/2017.

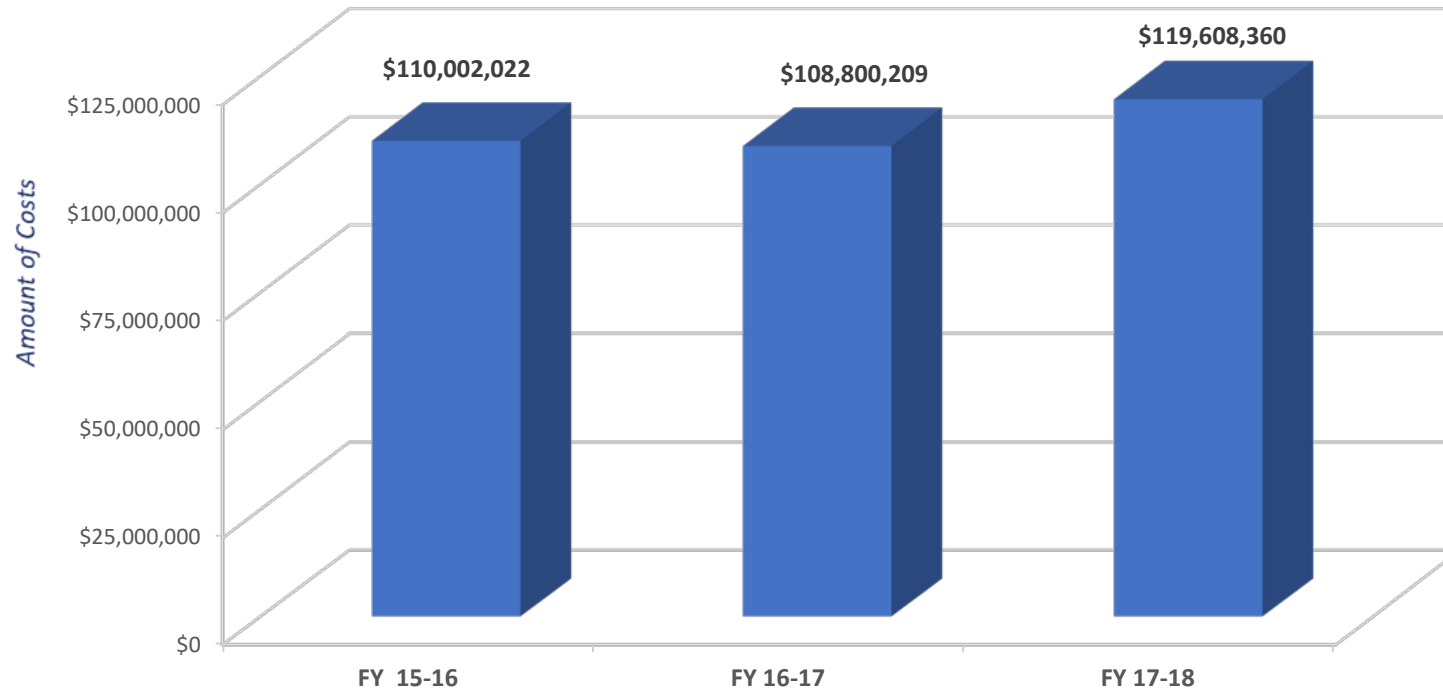

FY2018 DRM Total Expenditures of \$225,501,133 By Major Category

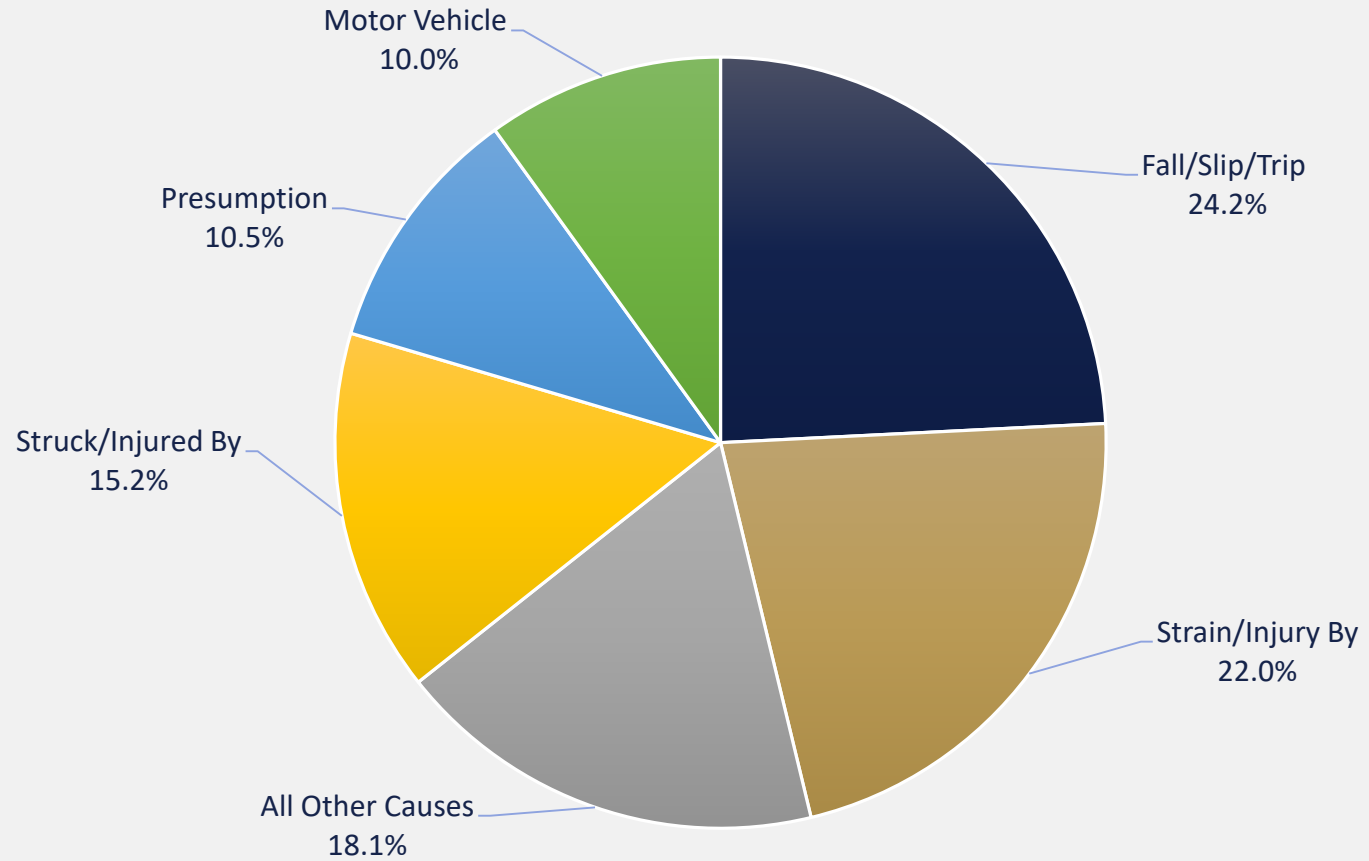

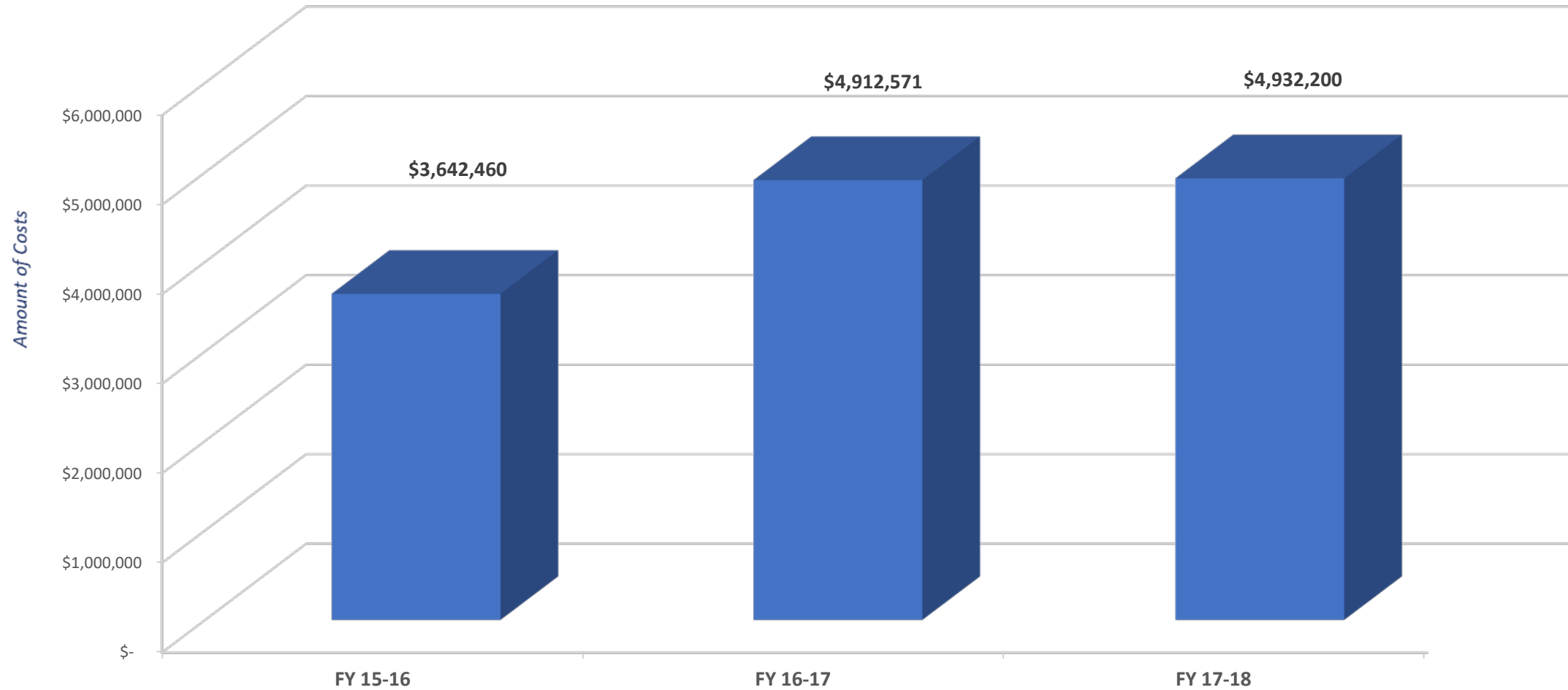
Return to Work Program Summary

- Total cost of lost-time claims increased by over \$2.8 million from FY 2016/17.
- Number of lost-time claims increased; 788 claims in FY2017/18 compared to 745 claims in FY 2016/17.
- Percentage of WC claims that are lost-time increased slightly with 7.15% compared to 7.01% in FY 2016/17.
- The number of TPD claims increased by 15.74%, and TPD claim costs increased by 28.87% compared to FY 2016/17.
- 24,916 days that injured state employees were at work due to RTW programs instead of at home collecting benefits, a 2,757 day increase compared to FY 2016/17.

Florida Automobile Liability Claims Cost Comparison

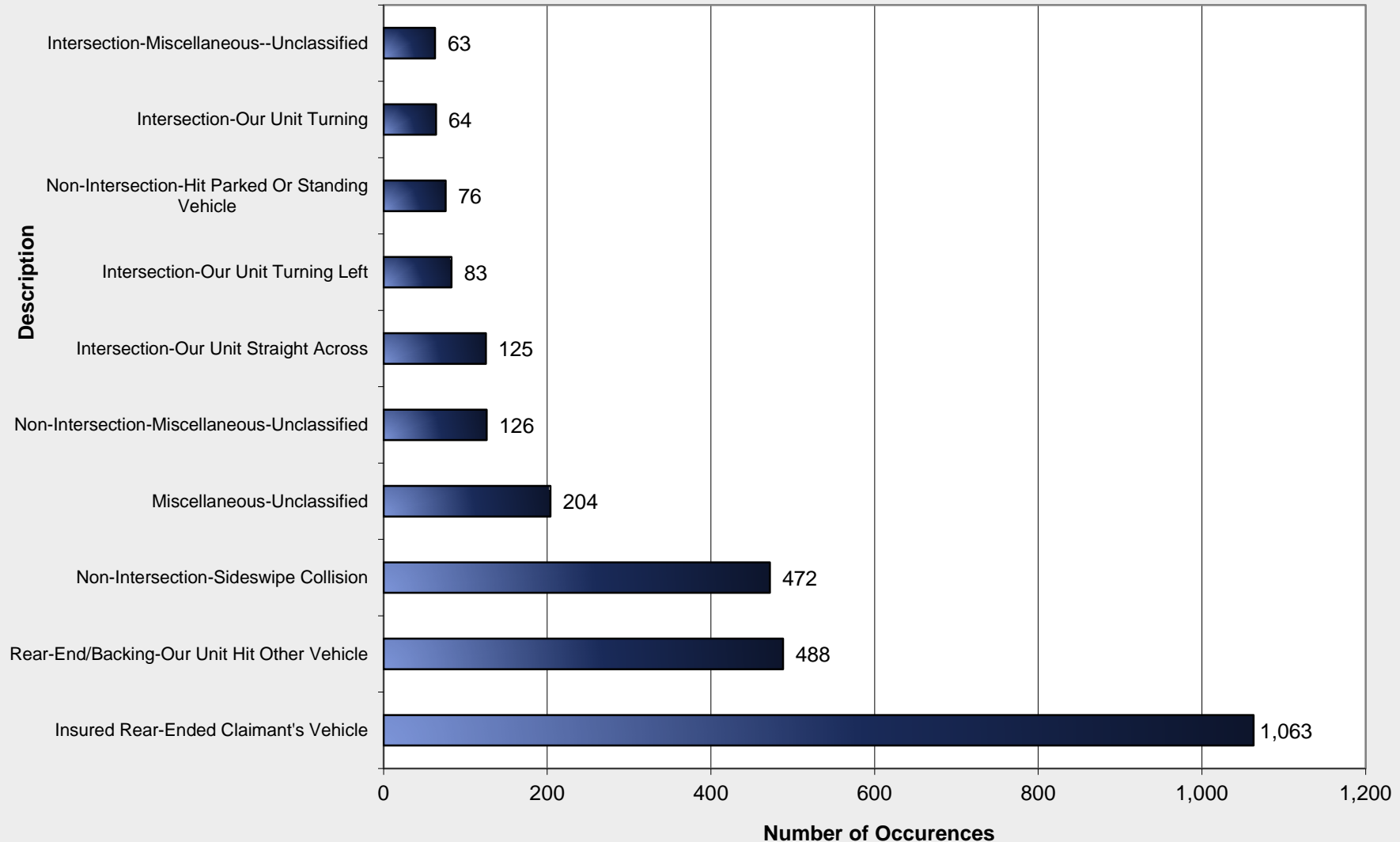

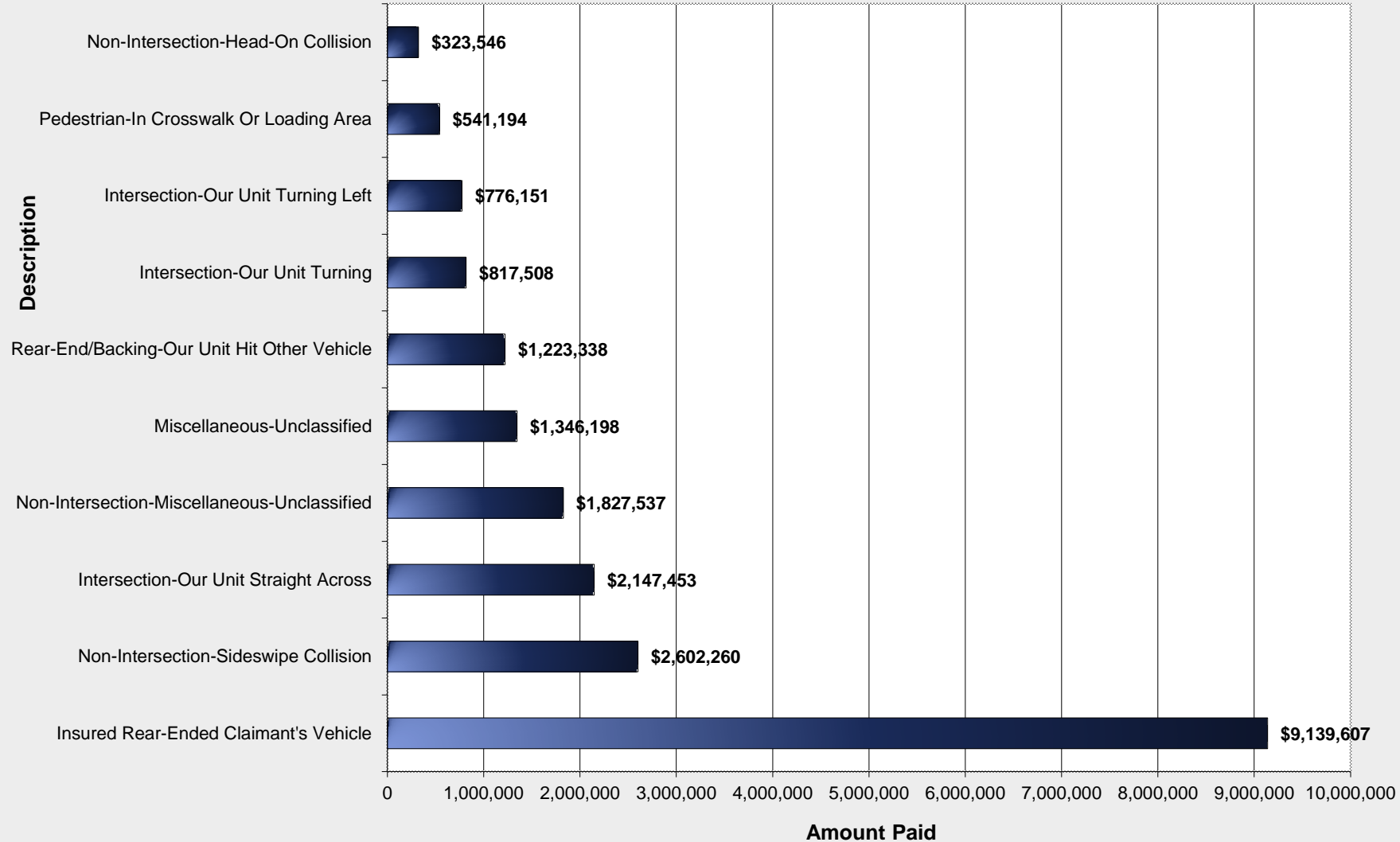


Frequency of Automobile Liability Claims - Top 10 Categories

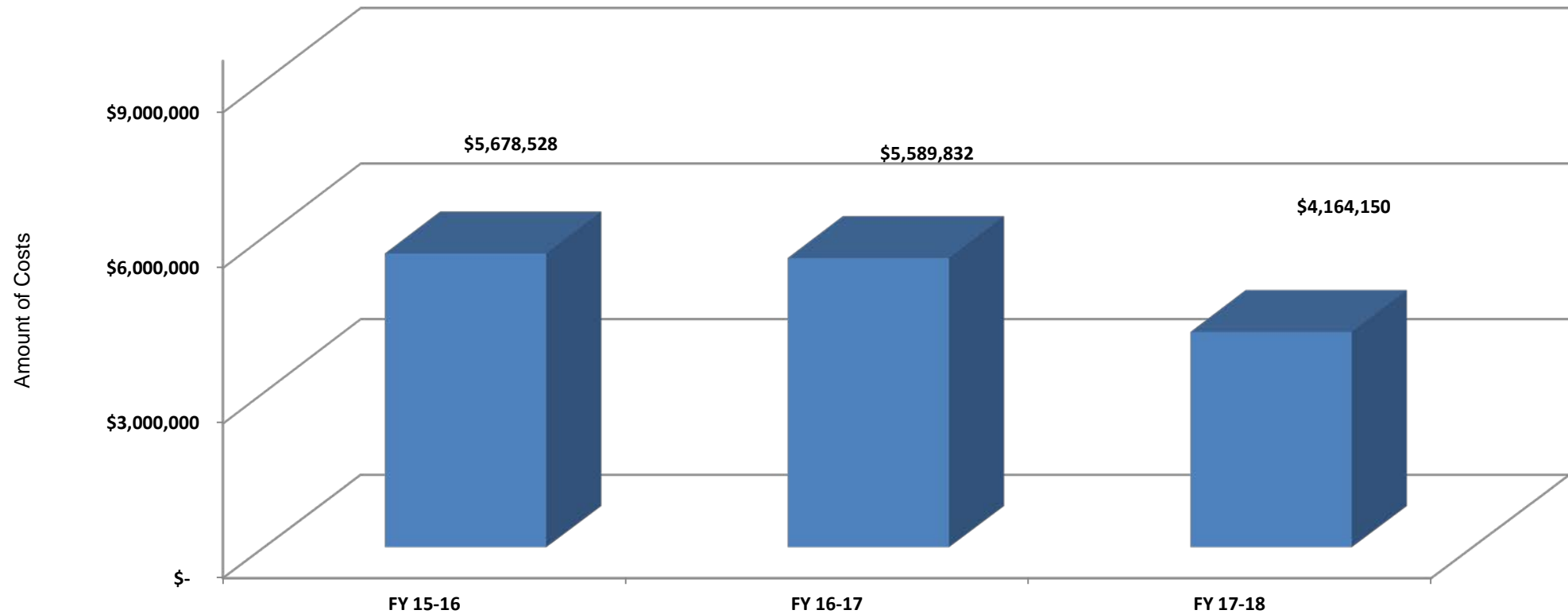

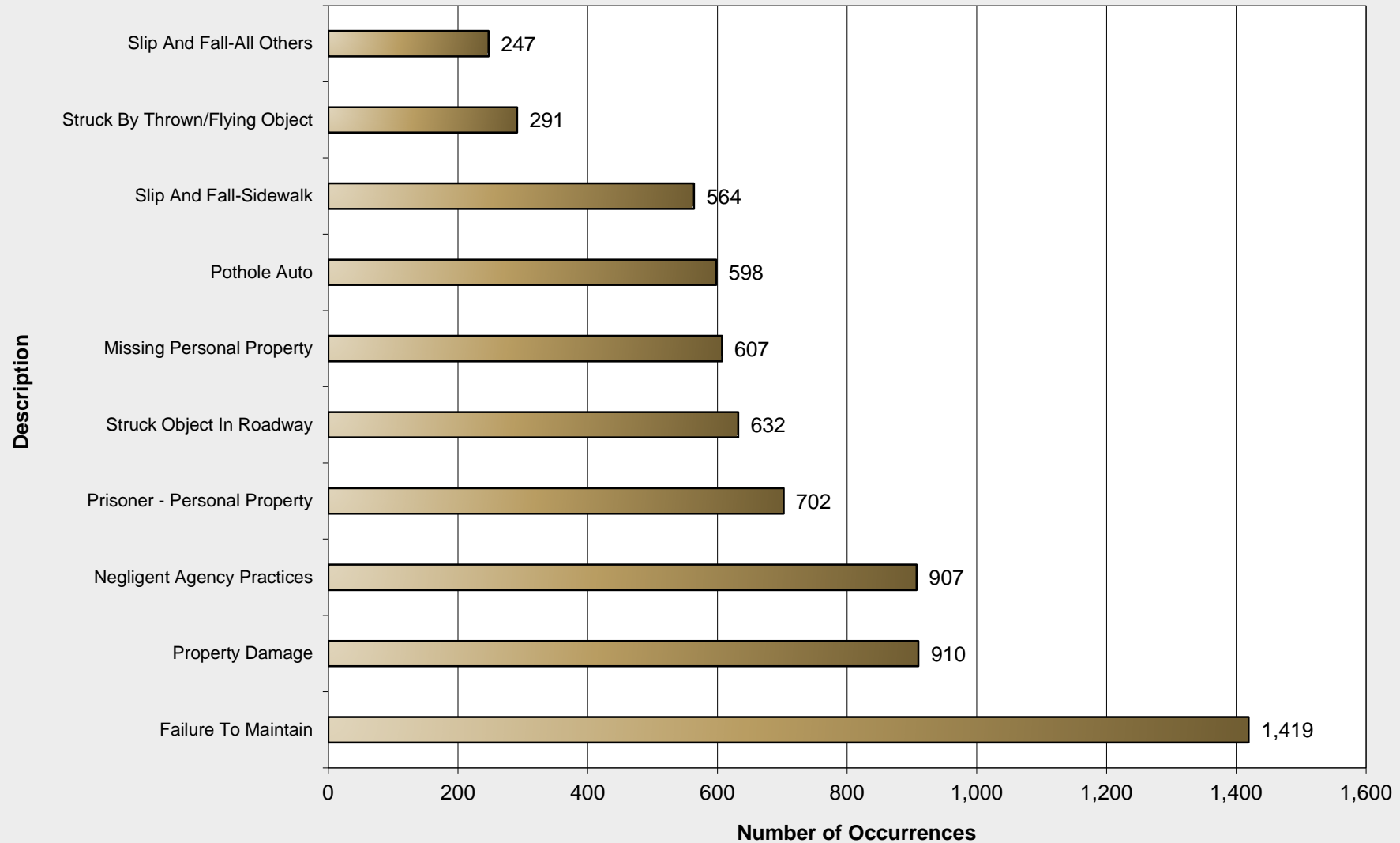
Cost of Automobile Liability Claims: Top 10 Categories
For the Period 7/1/13 - 6/30/18



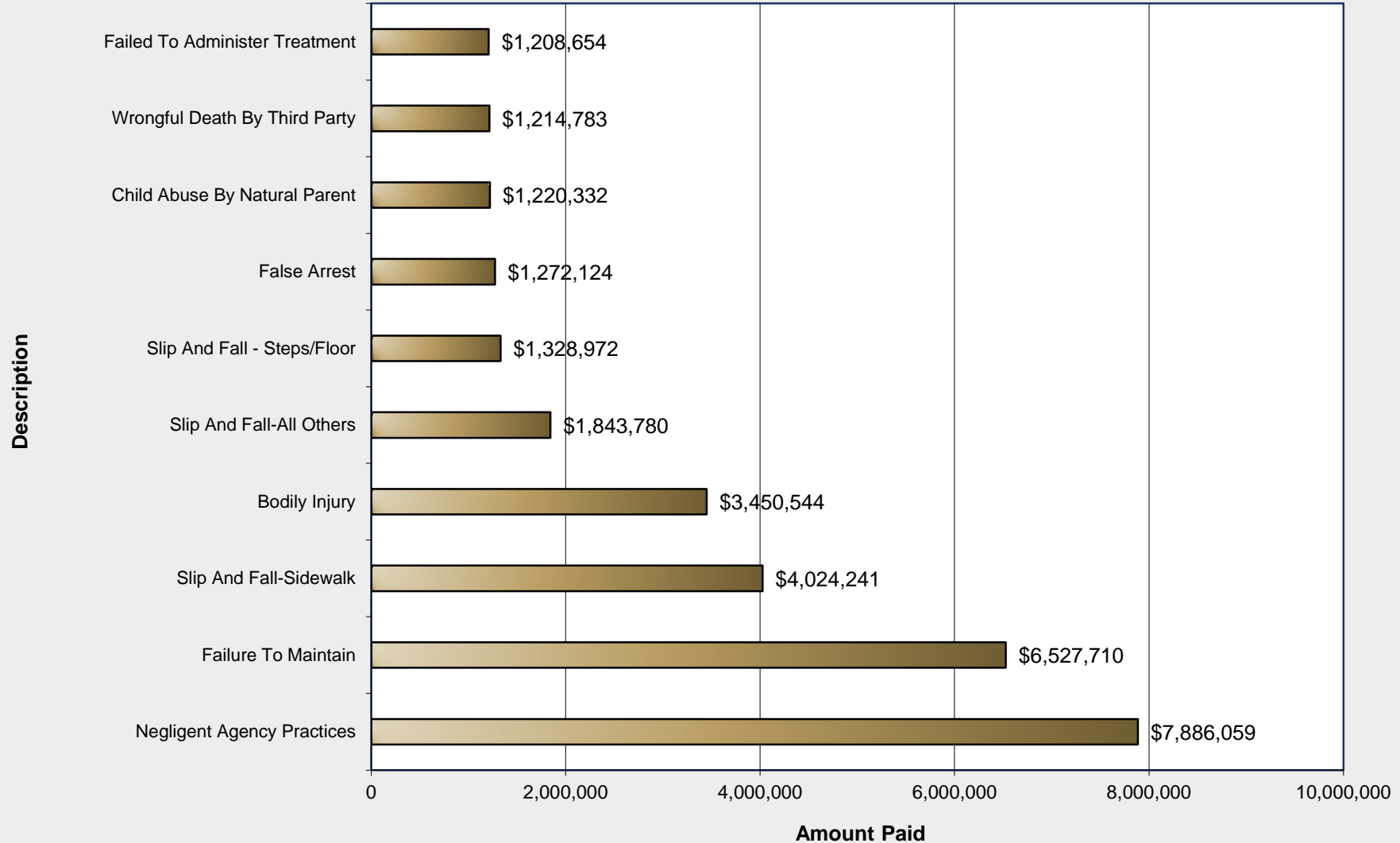
Florida General Liability Claims Cost Comparison

FY 2015-16 through FY 2017-18



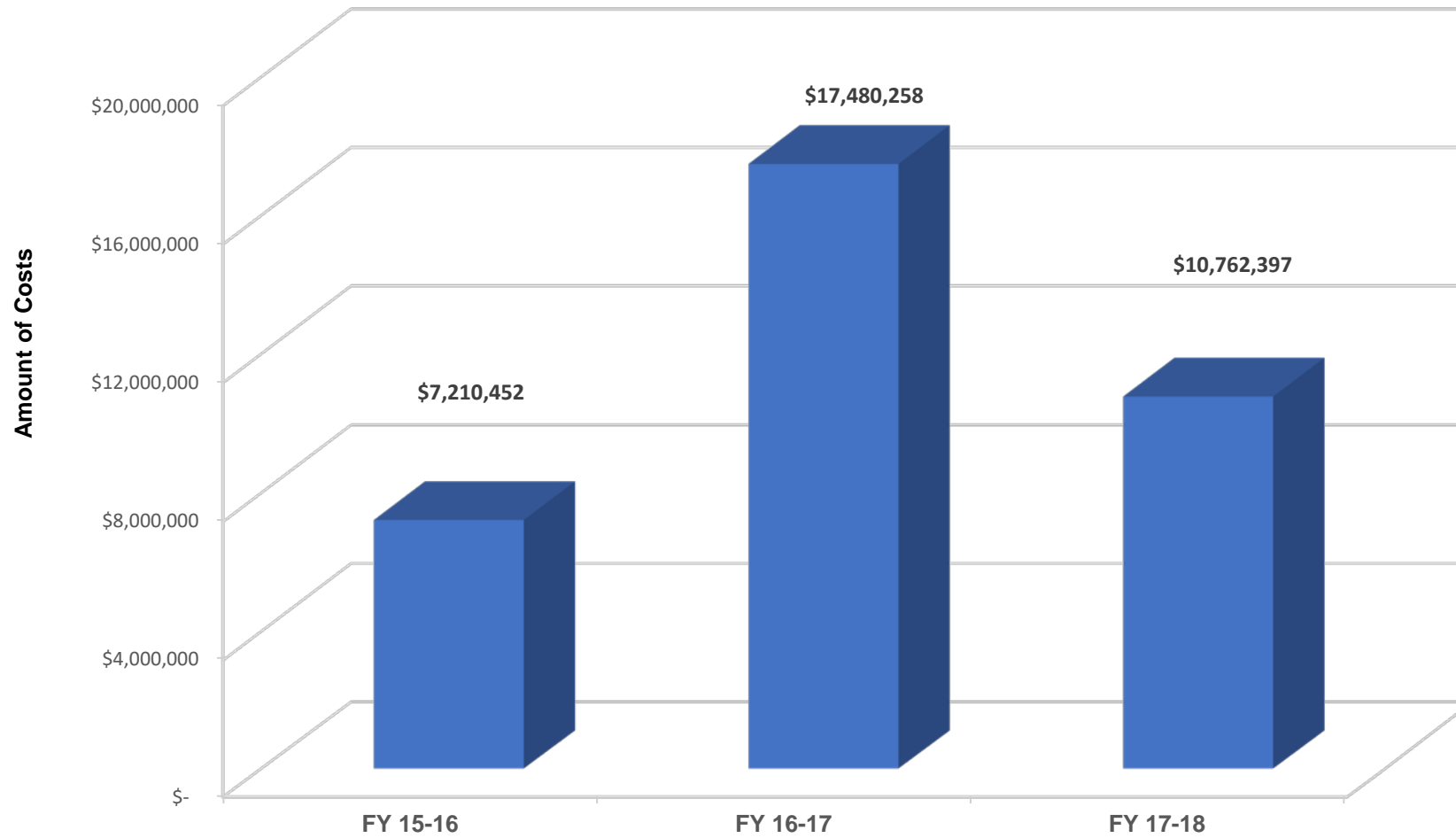
Frequency of General Liability Claims - Top 10 Categories

For the Period 7/1/13 - 6/30/18

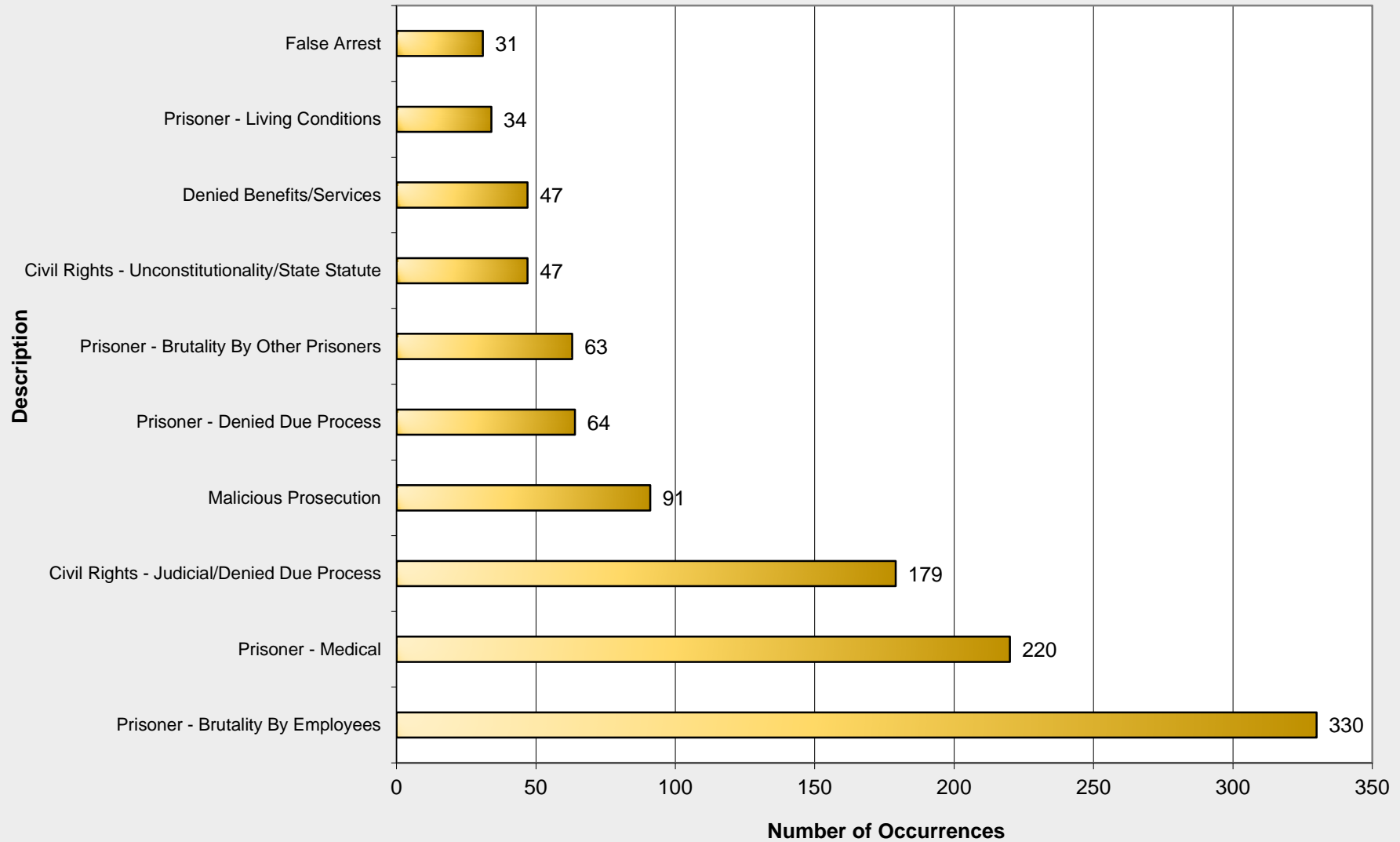


Florida Federal Civil Rights Claims Cost Comparison

FY 2015-16 through FY 2017-18



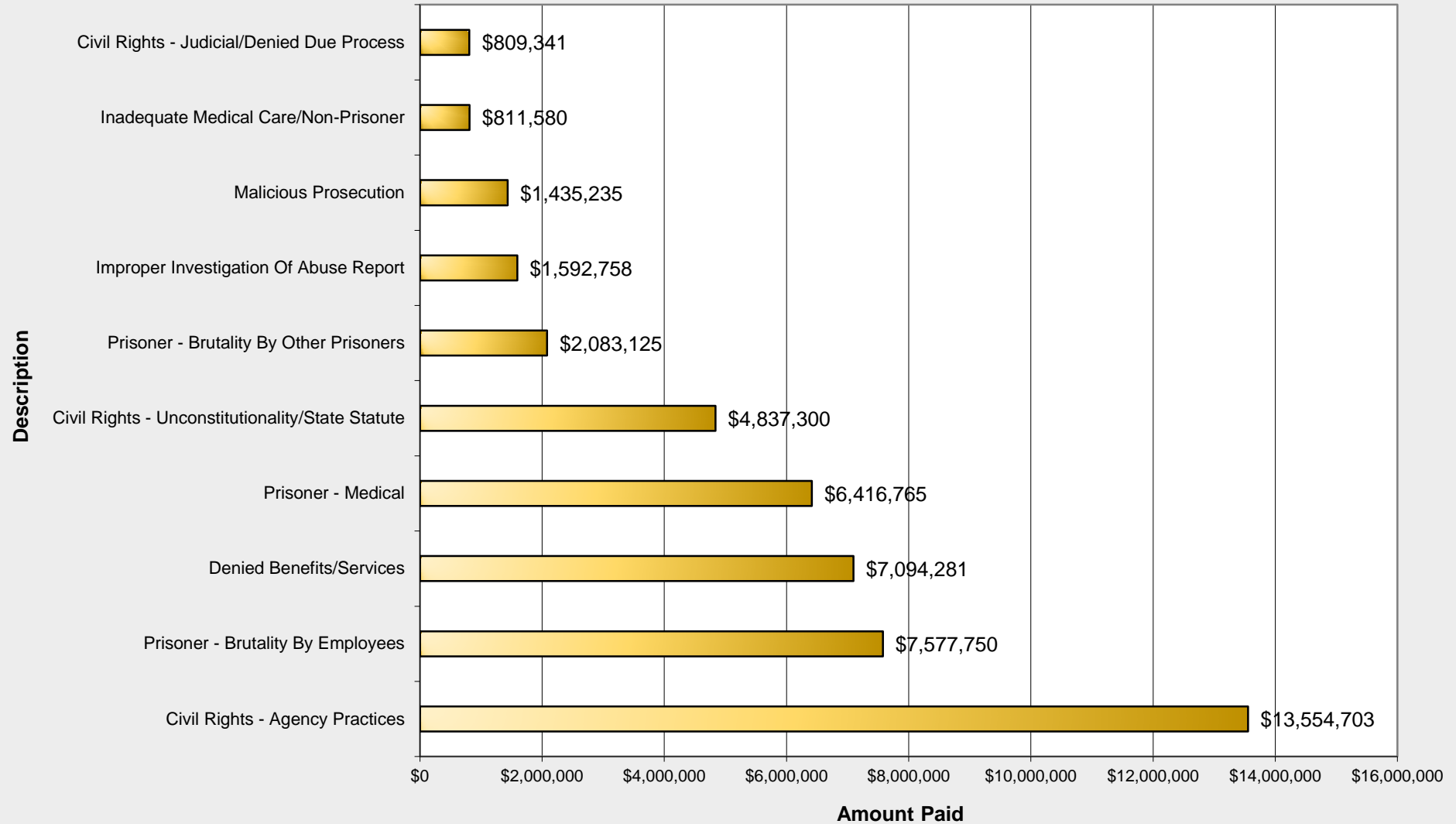
Frequency of FCR (Non-Employment) - Top 10 Categories

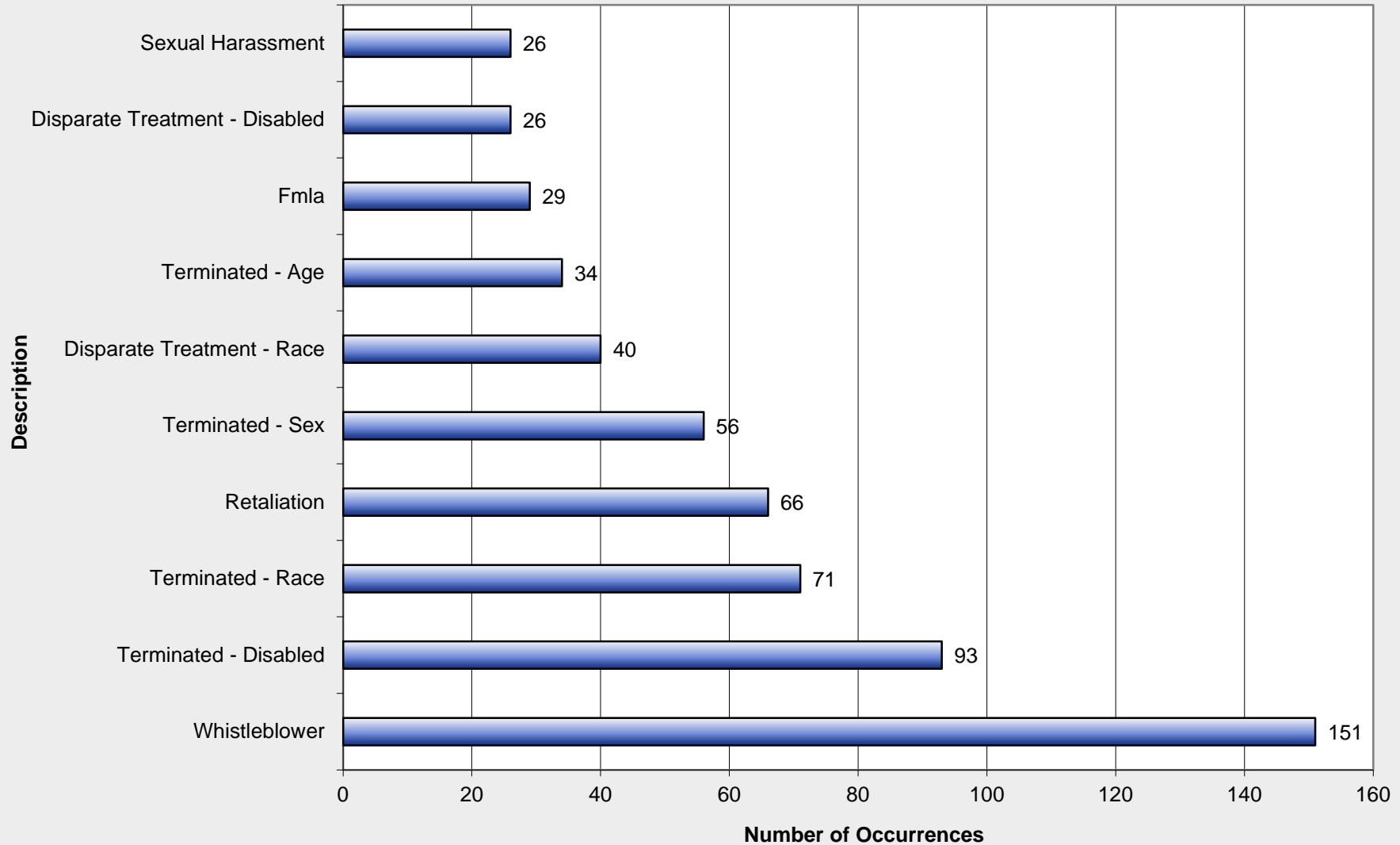


Cost of FCR (Non-Employment) Claims: Top 10 Categories

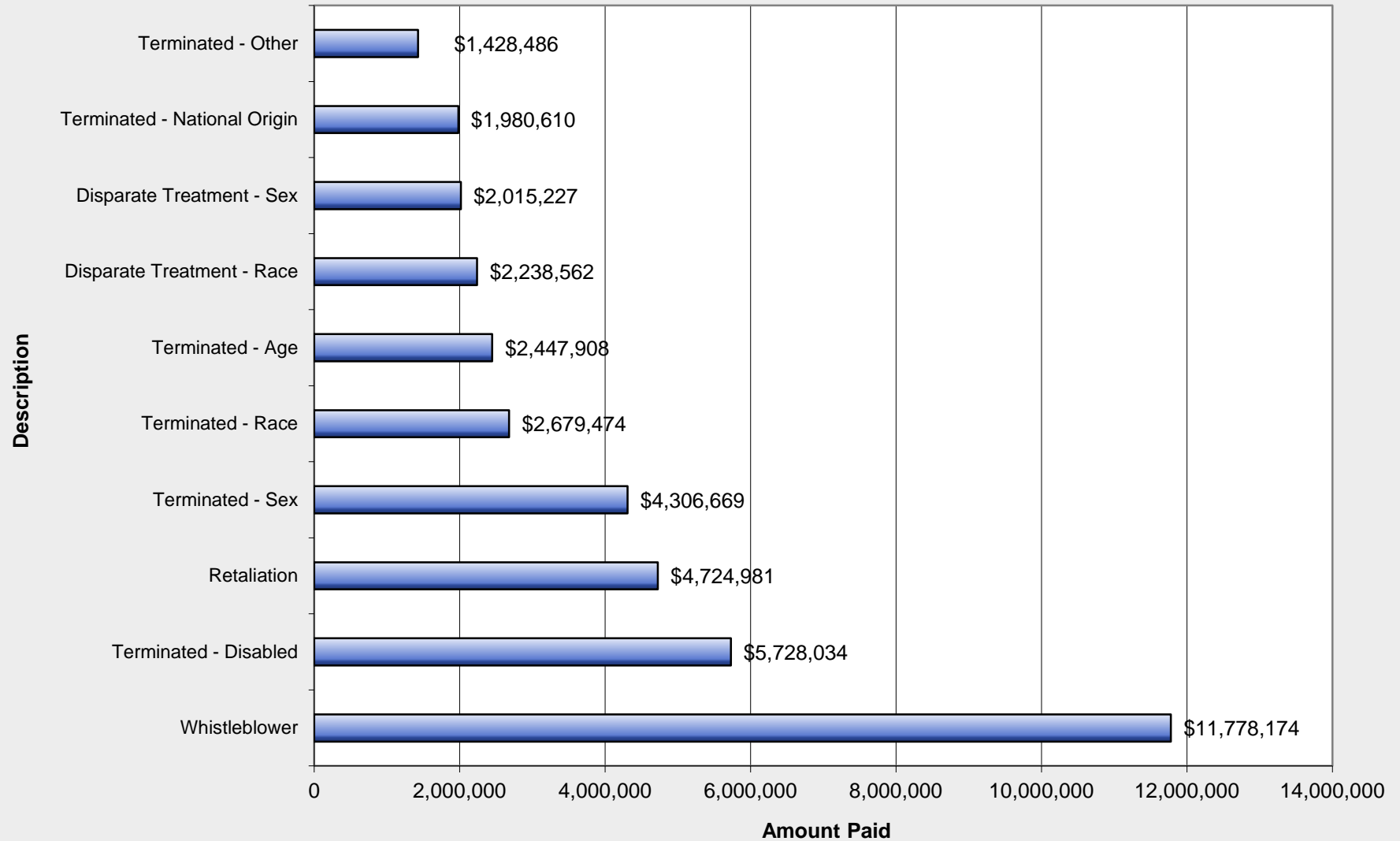

Reported for the Period 7/1/13 - 6/30/18



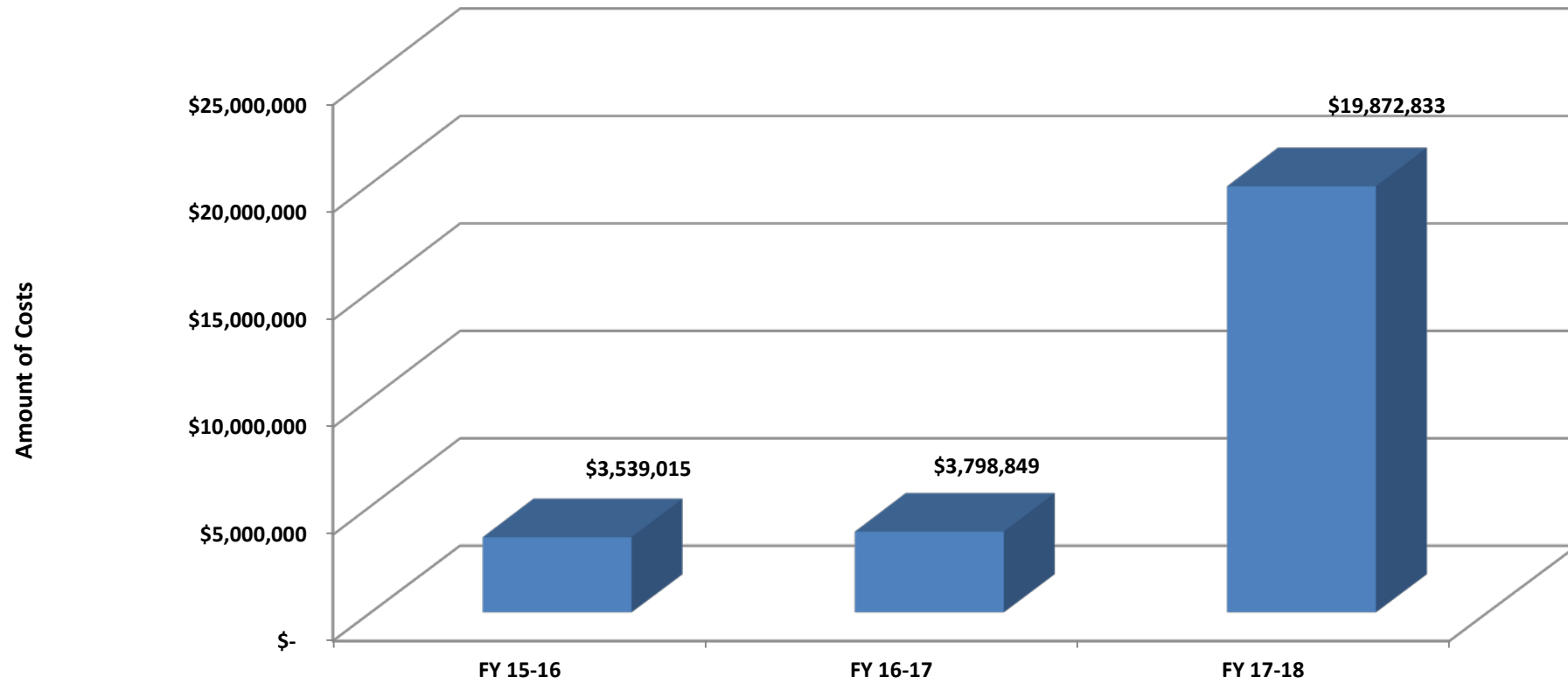
Cost of Employment Claims: Top 10 Categories
For the Period 7/1/13 - 6/30/18



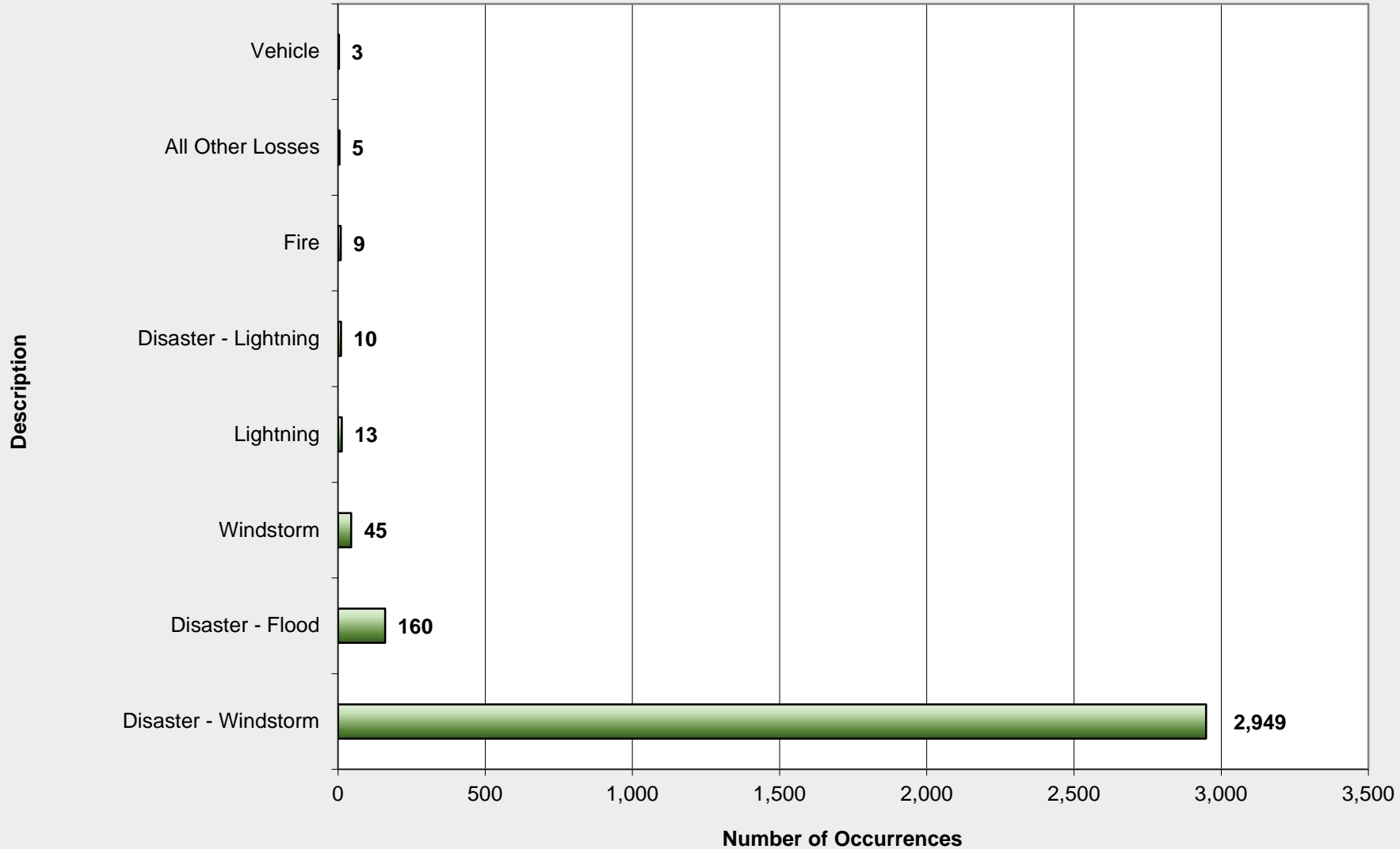
Florida Property Claims Cost Comparison

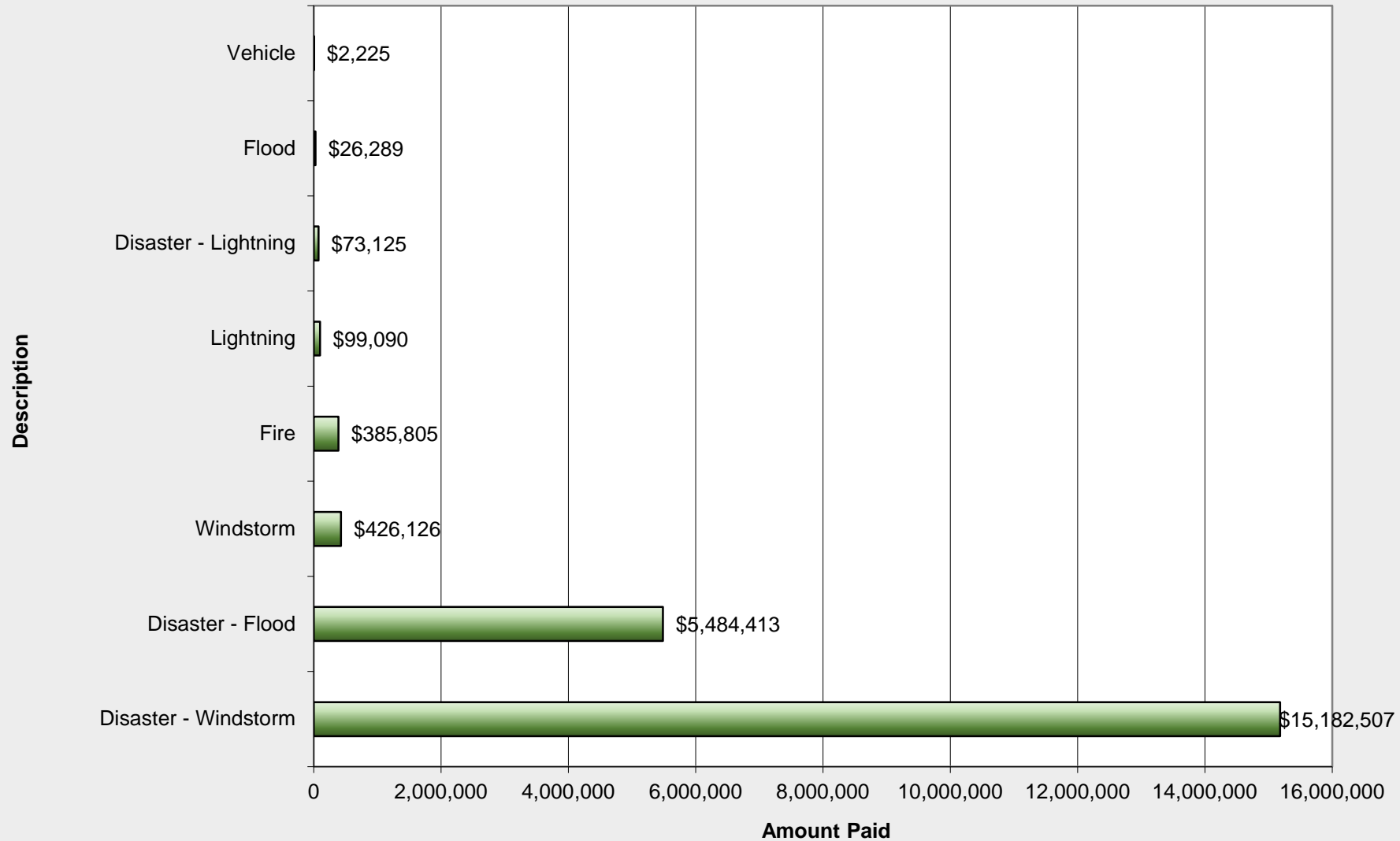
