Thank you for your interest in the Florida Firefighter Equivalency process for DOD Firefighters.

The first step of the process is to verify your training. Please submit the following proof of training along with a copy of your DD-214.

- Firefighter II IFSAC and/or Pro Board certification,
  - **OR**, the attached DFS-K4-1028 form with an attached letter from the Training Chief or Fire Chief, on official letterhead, that validates the number of hours.
- NIMS Training: IS-100, IS-200, IS-700, IS-800 (IS-200 and IS-800 not required for Firefighter I-Volunteer) <https://training.fema.gov/nims/>

- Hazardous Materials Awareness and Operations if not included in initial training. (Haz Mat Ops not required for Firefighter I-Volunteer)
