The first step of the process is to verify your training. Please submit the following proof of training along with a copy of your DD-214.

- Firefighter II IFSAC and/or Pro Board certification,
 - OR, the attached DFS-K4-1028 form with an attached letter from the Training Chief or Fire Chief, on official letterhead, that validates the number of hours.
- NIMS Training: IS-100, IS-200, IS-700, IS-800 (IS-200 and IS-800 not required for Firefighter I-Volunteer) https://training.fema.gov/nims/

- Hazardous Materials Awareness and Operations if not included in initial training. (Haz Mat Ops not required for Firefighter I-Volunteer)
- NWCGS: S-130, S-190, L-180 (L-180 not required for Firefighter I-Volunteer)

- Verification of no more than a four (4) year lapse since certification was issued or from last date of employment.
