SB 808 – Treatment by a Medical Specialist (s. 112.18, F.S.)

- Compensable presumption claims TB, HTN, Heart disease
- Written notice of selection of specialist
- 5 days authorize & schedule alternative or...
- IW selection is authorized

SB 808 – Treatment by a Medical Specialist (s. 112.18, F.S.)

- Continuing care...reasonable, necessary, and related to...
- ...reimbursed at no more than 200% of the Medicare rate for a selected medical specialist...and be authorized by the E/C
- Medical specialist defined 458/459
- Effective 10/1/2024

- HB 989 DFS Agency Bill (CFO)
 - Reimbursement for emergency services and care as defined in s. 395.002 which does not include a maximum reimbursement allowance must be 250 percent of Medicare, unless there is a contract, in which case the contract governs reimbursement. Upon this subparagraph taking effect, the department shall engage with an actuarial services firm to begin development of maximum reimbursement allowances for services subject to the reimbursement provisions of this subparagraph. This subparagraph expires June 30, 2026.

•SB 362 – Medical Treatment Under the Workers' Compensation Law


- •\$200 \$300 witness fees
- •110% 175% non-surgical
- •140%-210%surgical

- •SB 362 Implemented to align with HB 487 (2023)
 - Fee schedule published 7/1/2024
 - No longer subject to 3MP
 - ...as of 1/1/2003, whichever is greater
